Hi Marcia,

I hope you are doing well.

Here is a summary of my discussion with Mr. Constantino.

The City only has one address listed for this parcel. Consistent with what is included in the email below, we did identified that Ramsey County list 410 Virginia address as its primary contact address. This was the address the hauler has been using to bill the resident for service in the first quarter bill for 2019. We did note that the 410 Virginia street address was different than the 346 Fuller address the owner of this property thought we should be using, but we will continue to use the 410 Virginia street, as that is what is listed with the county. If the resident wants to have the bill go to another address he would have to work with the county to update the primary contact address.

I told Mr. Constantino that I would send an email to ensure Republic is servicing his property. Republic did respond that they have been and will continue too, provide garbage service to the property.

I did tell Mr. Constantino that I would send (and did send) an email Advanced to ensure they stops servicing the dumpster at the property. He understands that this is a 4 plex and the service be provided by the designated hauler under the new coordinated garbage program. I agreed to do this as a courtesy to Mr. Constantino.
