RE: Making Finding for Remove or Repair of the Building at <u>957 Prosperity Avenue</u>.

Dear Owner(s) and/or Interested Parties:

Legislative Hearings were conducted on May 28 and June 25, 2019 before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant 180 days on June 26, 2019 for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **January 14**, **2020** at **10:00** a.m. in **Room 330** City Hall at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If the owner received a Certificate of Code Compliance by January 14, 2020, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If the owner has *not* received a Certificate of Code Compliance by January 14, 2020, he or she will need to contact Joe Yannarelly (<u>joe.yannarelly@ci.stpaul.mn.us</u> or 651-266-1920) to schedule an inspection to occur *prior to* the week of January 14, 2020. Both Mr. Yannarelly and a building inspector will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, February 5, 2020 at 3:30 p.m. in City Council Chambers, Room 300 City Hall, 15 West Kellogg Blvd., Saint Paul.
