

The City of St. Paul has proposed to divide Ayd Mill Road's four lanes into two traffic lanes and two lanes for bicycle and pedestrian use. At first glance, that seems like a good way to cut the city's road maintenance bill and benefit area bicyclists.

But a closer look raises concerns. Emissions are expected to increase on Ayd Mill and on parallel local streets as traffic becomes slower, "calmer" and more congested. That alone should be an enviro no-no in a town with its own resilience and sustainability ethos that targets a carbon neutral 2050. Moreover, the placement of the bike/hike trails over the easternmost auto lanes -- those next to the railroad tracks – will impede trail performance and pose a safety risk for users forced to cross the active auto lanes to access the city street and sidewalk grid. And, as always, there is no provision for the elusive north end connection to I-94, meaning the current traffic mess at Snelling and Selby will intensify as the area itself becomes the economic growth magnet envisioned by planners and investors.

A greener and more efficient alternative exists by having the state, not the city, rebuild Ayd Mill Road as a two-lane, limited-access parkway fully connected to I-94 with no on/off access between Randolph and I-94. As such, it would function as an autos and transit-only "connector" deployed over the east side of the available right of way just west of the existing freight rail tracks. The parallel bike and pedestrian trails would then move to the west side to be more easily and safely connected to the neighborhood street/sidewalk grid and to trailside development opportunities.

At over 100 feet, the available right-of-way easily accommodates a two lane, 60-foot wide auto parkway that includes shoulders and center median barriers, 18 feet of bike/hike trail parkway and a 10-foot buffer zone with safety and

noise barriers. Area drivers negotiate this sort of configuration every summer during construction season and thus should easily manage single file driving over the 1.6-mile parkway connector at moderate, quiet, 45 mph speeds. The parallel unimpaired "trail parkway," with no street intersections or stop signs, will increase the reach of the bike network by several miles per hour and facilitate a seamless connection with the Midtown Greenway when it is ultimately extended east into St. Paul.

So, let's move past the short sighted, low-budget city proposal and go big with the parkway auto, transit and trail connector, where virtually all users will move from end to end faster and more efficiently. If you agree, tell your elected representatives that there is a better, safer and greener way to repurpose Ayd Mill Road.

The Ayd Mill Redo: Commuters Lose Again

With the city's proposal to slow down Ayd Mill Road (AMR) from four to two lanes, we are seeing yet another local transportation infrastructure venture catering to squeaky-wheel special interests while ignoring those who actually need to get to work or school on time. The disruptive Green Line, at 17 mph, is no faster than the bus it replaces, while the proposed 15 mph Riverview Modern Streetcar will actually be slower. Very few get to work faster or gain access to more jobs using these conveyances despite the billions spent and promises made.

Sadly, the Ayd Mill plan is really no different, slowing auto and future transit traffic over another key commute corridor to 80% of current speeds and to about half of what a reimagined thoroughfare could be. All this because the city lacks resources to rebuild AMR in kind, much less connect it to I-94, but yet has the funds to repave two of the AMR lanes as trails, even though less than 10% of city commutes are bike and hike while over 80% are transit and autos. Where is the equity in that?

The AMR corridor can, however, be redone to benefit all relevant stakeholders. For starters, recognize that it is a regional thoroughfare and that the state, not the city, should rebuild it. An attractive option, then, would be a two-lane, limited access, auto/transit parkway fully connected to I-94 running just west of the existing freight rail tracks, with neighborhood on/off points limited to the Allianz Field area and Randolph Street endpoints. At quiet, 45 mph, nonstop parkway speeds, it would be more efficient than the stop-and-go city plan for AMR and more effective at keeping city and suburban cut-through traffic off nearby city streets. The parallel bike and pedestrian trails would then move to the west side of the right-of-way to be more easily and safely connected to the neighborhood street/sidewalk grid and to trailside development opportunities. As such, there would be no stoplights encountered by cars, bikes or walkers and no additional right-of-way needed except for several acres where the I-94 connection would be built.

This "Parkway Connector" concept addresses some inconvenient realities:

First, that auto traffic via the corridor is not going away because corridor jobs are not going away. Eagan on the south end has over three times the industrial and office acreage than St. Paul's Midway area on the north. That differential will only grow as Eagan fills in and the Midway converts to apartments and condos to accommodate St. Paul's growing population and changing lifestyle preferences. These residents need efficient access to Eagan jobs as much as Eagan residents will still need to reach jobs in the cities. They might be in 50 mpg cars that drive themselves or 60-foot long bus trains, but they won't be riding bikes.

Second, that the I-94 connection will help secure critical bi-partisan, regionally focused funding support that will need to go much deeper than the cash-strapped city plan. There will be faster commutes, increased mobility, transportation-oriented development and construction jobs for one political stripe; transit equity, sustainability, bike paths and construction jobs for the other. What is there not to like ... or vote for?

And finally, the city's 2050 sustainability plan will be attained through technology, lifestyle changes and the fair and full pricing of carbon emissions, not punitive road diets that further congest neighborhood streets and frustrate neighborhood drivers. Los Angeles, of all places, points the way here. Their air today is much cleaner than in 1970

thanks to catalytic converters, higher mileage cars and better transit, even though population is up 80%. That air will be cleaner still in 2050, whoever may still live there.

If you agree that an AMR parkway connector concept can benefit all users, tell your elected officials - Republicans and/or Democrats - as much. Tell them that a better, safer AMR is possible that would also, for a change, be faster. What a novel idea.

The Saint Paul Bicycle Coalition still supports the Mayor's proposal for an Ayd Mill bicycle and pedestrian pathway, despite its revision. While we would prefer that both of the eastern lanes of Ayd Mill Road be converted to a bicycle and pedestrian pathway, we would rather get one lane as opposed to no lanes.

This project comes to the city at a time of tight budgets. In order to save money, the city is implementing its bicycle and pedestrian plan, whenever a street gets resurfaced or reconstructed. Since Ayd Mill is being resurfaced, this is the perfect time to implement the off-street trail called for in city plans. Whether a bikeway is added to the project or not, \$3.2 million dollars will be spent resurfacing the roadway, plus additional million(s) to fix drainage issues and put in new, permanent signal lights (to replace old temporary ones). The creation of a bikeway is a small percentage of the overall \$7.5 million cost-- just curbs, lighting and a small amount of new paving to make pathways at the five exits (Selby, Hamline, Grand, St Clair and Jefferson). The bonding for this extra cost would be paid for out of dedicated bicycle funding and we think the project is important enough both in and of itself and as part of a possible Midtown Greenway Extension to warrant the use of dedicated bike funds.

While the mayor's currently proposed trail and 3-lane roadway becomes less of a linear park and more of just a protected bikeway, we appreciate that it's also \$2.4 million cheaper than having to add additional roadbed to create new left turn lanes on the west side of the road for the original 2-lane proposal. We also appreciate that the extra money from the abandoned Woodlawn Avenue project happens to be available now and probably won't be available in the future, and we appreciate that putting this project off for another year will inherently make it even more expensive, because project costs go up every year due to inflation.

Some council members have complained that there has been insufficient public process for this project but they forget that there was almost 20 years of intensive public process from the late 1980s thru the late 2000s. This included a full Phase 1, Draft Environmental Impact Statement process, in which a Citizen Task Force backed by public comments voted for a linear park. Hundreds of citizens put in thousands of hours into this Task Force and its accompanying public meetings. The city completely

ignored this public process and the mayor at the time unilaterally opened the south end of the roadway and tried to connect the north end to I-94 over intensive public opposition. So we believe that it's inaccurate to say there's been no public process. In fact there has been more public process on Ayd Mill Road than any other roadway or street in the history of the city. It's just that past councils and mayors decided to ignore the public, or we'd currently have a linear park down there instead of a roadway. Because only one current council member participated in this process and knows the history of it, we attach a historical timeline of decisions on the roadway prepared by the Union Park District Council Transportation Committee.

Other council members have expressed concerns about traffic going onto adjacent streets. We believe the revised proposal makes this even less of a possibility because it makes absolutely no changes to the road in the southbound direction and the northbound road is already just a single lane at both ends (at I-35E and where it merges onto Selby Avenue). In the unlikely event a problem should arise in the northbound direction, the Public Works Director has pledged to create a mitigation plan and funding.

More importantly, it's time we stopped making "the avoidance of traffic congestion" the focus of our infrastructure decisions. We should instead prioritize access and safety of all road users. We could put it off a year but nothing will change. Budgets will only be tighter, the project will be more expensive (thanks to inflation) and the road will be in even worse condition. The time to act is now.

Dear Councilmember Jalali,

My name is Gene Johnson and I spoke with you about Ayd Mill Road (AMR) at Mayor Carter's Birthday Party in January at the Minnesota Music Cafe. I just listened to the recording of the Public Works

Presentation regarding AMR that took place on February 12th. I sincerely hope that you have time to review the following prior to the Council Meeting on the 19th.

First of all, I support the goal of reducing the number of fossil-fuel-based cars on the streets of St. Paul. I also believe that the plan presented by Public Works Director Kathy Lantry is an appropriate redesign of the AMR Corridor. However, I support the reasons put forth by other Councilmembers regarding why this plan should not be implemented this year. Here is my reasoning:

- 1) Recognize that Ayd Mill Road is a Regional Corridor In your comments towards the end of the meeting, you said,
- "...this is part of a long-running community effort to connect Minneapolis & St. Paul through a bike network that would go across the river, through Midway, take people to and past Allianz Field. It would mitigate a lot of the car traffic because we would be connecting people between cities like an actual commuter route and this road is a key leg of it...".

The AMR Corridor could and should be part of this proposed bike-commuter route when it is finally built. However, the study done by the Midtown Greenway Coalition pegged the cost of crossing the Mississippi River on the Canadian Pacific Bridge at between \$7M and \$22M with no sign that Canadian Pacific is willing to grant access to the bridge now or in the future. I am not pointing this out to suggest that doing so is an undesirable goal; I'm merely saying that the needed work on AMR should not be deferred as long as that difficult issue remains unresolved.

<u>The other regional aspect</u> of this are commuters who live in Dakota and Washington Counties. Limiting northbound AMR to one lane may reduce auto traffic on it from those suburbs but not eliminate it. What we should be working toward is using the AMR Corridor as an Express Bus connection via 35E from the Eagan Transit Station to the Metro A Line stop at Selby and Snelling. This would support your goal of reducing auto traffic from the suburbs while giving residents of Dakota & Washington County an option on how to access St Paul, Roseville, and Allianz Field without using a car. As much as it's important to give bike riders options, we should not be excluding others in the process.

- 2) Remove the burden of AMR from St Paul taxpayers and share the cost of making it a Regional Corridor with Ramsey, Hennepin, Dakota, and Washington Counties The most likely way to achieve this is to work in partnership with those counties to convince the State of MN that AMR is a Regional Corridor while putting together a plan that achieves the goals mentioned above.
- 3) Implement the original plan to do the \$3.5M mill & overlay to the existing AMR this year, delaying the bike lane & trail, lighting, sewer, traffic lights, etc. while the above efforts are undertaken. This would free up resources within Public Works for the maintenance of other streets in St Paul. It would also remove the need to commit \$500,000 from the Bike/Ped Fund over the next ten years as currently proposed by Public Works. If AMR is ultimately transferred to the State, future costs will be shared with others and not just covered by St. Paulites alone.

I sincerely hope you will give this proposal serious consideration. Copies will be forwarded to the Mayor and other Councilmembers so they also have an opportunity to consider this option as a realistic resolution. I look forward to seeing you at the 5:30 meeting on Wednesday.

Hello,

My name is Al Davison, and am a past resident of Ward 2 (and soon to be resident again in March). I drive, walk, bike, and take transit around St Paul, and visit the area around the Ayd Mill corridor on occasion (mainly along Summit and Grand). Council Member Noecker requested more feedback from her constituents regarding the future of Ayd Mill, so I would to provide my opinion about Ayd Mill Road.

I strongly support adding bike and pedestrian infrastructure in the Ayd Mill corridor, along with reducing the total amount of lanes from 4 to 2.

Given that Ayd Mill Road is just a Municipal State Aid Street (MSAS 195), and not a county or state trunk highway - the city should acknowledge that they can't support maintaining an expressway, nor should they encourage to do so. The city alone can't afford to maintain an 4-lane expressway, and it's unlikely that Ramsey County or MnDOT would take over jurisdiction over Ayd Mill. Therefore, we don't have the funds to keep it as a divided 4-lane roadway over the long-term.

MnDOT currently has a "super-2" layout for US Highway 12, which is a 2-lane highway that bypasses Orono and Long Lake which carries a similar amount of traffic to Ayd Mill (24,500 AADT in 2018 via MnDOT's Traffic Mapping Application). While people in that area tended to prefer a 4-lane option, MnDOT did not have the funding for it - so they did what they could with their limited funding. We need to acknowledge that we can't always keep maintaining nor building wide roadways, and we need to make the best use of balancing out our funding for roadways. At times we have overexpanded roadways that we can't truly afford from a long-term perspective, and Ayd Mill is a prime example of that.

With a lane reduction of Ayd Mill, there will be some traffic switching over to other minor arterials and collector routes nearby such as Lexington Ave. It is likely most traffic would stay on Ayd Mill though as even with a two-lane layout, the endpoints of Ayd Mill at Selby and 35E are only two lanes anyways. With it's few access points, two lanes is adequate if turn lanes are able to still exist at the intersections with ramps to Hamline, Grand, and St. Clair. It is better to keep regional commuters on trunk highways anyways, as suburban commuters from Dakota County can take Highway 55 instead if they are heading towards Minneapolis and beyond. Two lanes is adequate for Ayd Mill and it would better promote it as a local access route than a commuter route used as a shortcut to avoid stoplights on other nearby roadways.

I used Ayd Mill often to get back to a warehouse on Pierce Butler when I was doing traffic counts around the metro. While I liked being able to use it to to access Hamline easily from 35E, the four lanes seemed unnecessary. It promoted unsafe behavior such as aggressive lane changes and speeding rather than being used to support the minimize traffic congestion (which reminds me of what I constantly see on 4-lane undivided roadways such Dale and Rice St).

Adding a route for people walking and biking would help add a safe route for residents and visitors in this part of Saint Paul, and potentially could connect with the Midtown Greenway in Minneapolis in a long-term scenario. A mixed-use path would be an asset to the city and would help improve the city's

goal to become more multimodal. Having a bike route between Marshall and Jefferson would be a great crosstown bike corridor. It would be great to walk/run along Summit and then be able to walk along a rehabbed Ayd Mill.

Reducing Ayd Mill from 4 to 2 lanes along with adding bike and pedestrian infrastructure isn't to penalize drivers (as some may think), it's to create a multimodal corridor that would improve safety for everyone. It would benefit both residents and visitors to the area as it would add more parkland (as a linear park) for the surrounding neighborhoods.

I hope that the Council votes for a multimodal Ayd Mill.

As a resident of Summit Hill, a vehicular user of Ayd Mill Road, a bicyclist, and an advocate for St Paul's climate goals, I urge you to support the updated plan to refurbish Ayd Mill Road, removing at least one traffic lane and adding a multi-use path in the Right of Way. Ayd Mill, in its current condition, is unsustainable - it is a massive sink of road repair dollars, and simply re-paving it will at best delay its wear. Any project which reduces the number of vehicle lanes is a good financial goal, reducing the scope of any annual repairs. As long as we have heavy vehicles traveling on a roadway in a creek bed, we will continue to send good money after bad.

Secondly, the construction of a multi-use path in the freed right of way is consistent with the long term plan established for Ayd Mill Road over 10 years ago, and consistent with St Paul's climate action plan. Ayd Mill Road would represent a valuable North-South connector between my friends, bicyclists, recreators, pedestrians, and car-lite families in Mac Grove and W7th. Thank you, Jane, for your timely and considered response.

I don't personally find the argument that an Ayd Mill redesign will reduce car dependency compelling. My perception is that the street exists primarily for--and is used by--people who are trying to connect to major freeways. That is, people who are passing through in an effort to get to places further away, both within and outside of the city, for whom a bike would not be useful.

I am curious about use studies, if they exist, that show redesigns of this sort would actually result in substantial numbers of people ditching their cars, or if this argument is primarily theoretical/aspirational in nature. My perception is that data-driven arguments are scarce on this issue. It certainly seems

people who are *already* avid cyclists, particularly in Minneapolis, would like the redesign for the potential to connect to the greenway, but that is not the same thing as getting current drivers to ditch their cars and become new cyclists.

Working-class people with families who cannot simply choose to work where they live but must go where the work is are rarely-discussed casualties of commuter-hostile policies. I can't commute between E St. Paul, the U of M, and West 7th on a bike, and certainly not with a small child and her associated gear in tow.

If I may be frank: The level of social capital and economic privilege required to live and work car-free and maintain one's independence is quite high, and it's not a level most of the city is at. It is difficult not to wonder who exactly a project like this serves.

The East Side especially is not a place that can currently accommodate employing all of its residents, so the economic health of the area and opportunities for its residents are dependent on people being to able to get to other areas of the Twin Cities with as much efficiency, flexibility, and independence as possible.

Contempt for commuters is growing at the same time living close to good jobs in the city is becoming increasingly unaffordable. It seems to me that environmental and class politics are in very serious tension in St. Paul, and it is not likely those across the city most negatively affected by an Ayd Mill redesign and similarly-motivated projects will be able the muster their voices well enough to compete with the likes of the Sierra Club and its proxies. I am not particularly assured by the promise of public processes, but I hope I am wrong.

I appreciate you connecting me with your colleagues and look forward to hearing about developments as they happen.

Mayor Carter's original proposal for Ayd Mill Road was really exciting, and represented an actual change to the road. The current plan of turning only one lane into a trail right next to a lane of traffic is far less exciting, particularly with the much higher cost estimate.

If the choice is between resurfacing the road either with or without adding a bike lane, I would vote to include the bike lane. Ayd Mill Road is on the bike plan. The Climate Action Plan adopted last year includes buildout of the bike plan as a priority. If the Climate Plan and the Bike Plan are supposed to be meaningful documents, they should be followed when the opportunity arises.

That being said, at this price I don't think a relatively temporary fix for Ayd Mill Road is worth it, even if that means no bike infrastructure for now. Close it. See how much people actually miss it after it's been closed for a year, and in the meantime come up with some more exciting and meaningful alternative plans.

Seeing Public Works Director Kathy Lantry's observation that the road is unsafe for driving on at this point without millions of dollars of investment for a mill and overlay that is quite likely going to need to be redone within 5 years anyway, it seems that another option may have presented itself. Perhaps the City should consider taking the road out of service altogether at this time, as a public safety effort. Let it lay fallow for now. Hello, Mitra. I am writing to ask for your support for rebuilding Ayd Mill Road. I've lived in the Midway area since 1989 and in the Hamline-Midway neighborhood since 1995. I have used Ayd Mill to commute to my job in Eagan since 2013. But the surface has gotten so bad that I've taken to using Lexington to get down to the Randolph/35E ramp. I've tried using Hamline Avenue to Montreal/Shepard Rd/35E but Hamline is only slightly less bumpy than Ayd Mill.

It doesn't matter to me whether it's rebuilt as a four-lane or two-lane with bikeway. I think the two-;ane will work just as well. The 1.5-mile length doesn't provide much passing time. Phalen Parkway and Pierce Bulter are also two lane (with boulevard in one case and center left-turn late in the other), so havig Ayd Mill also with a two-lane solution would be consistent. As long as its north-bound left turns and south-bound merges into traffic are handled in a way that prevents backups, I don't think we need to cater to pass-through drivers trying shave seconds off their commute by providing a passing lane.

A definitive long-term solution to Ayd Mill Road is way overdue. It's been studied to death. In 1997, when the Ward 4 seat was open and several candidates were running, i served on the candidate information committee for the DFL endorsing convention. One of our questions to the candidates was about solutions for Ayd Mill Road. I can't believe that 23 years later, we're still talking about the problem instead of solving it. Mayor Randy Kelly's actions around 15 years ago were definitive, but only regarding the traffic flow. We have to fix the structure, too. Please, support the mayor's plan or some version of it to make Ayd Mill Road the road it deserves to be.

I am writing about my concerns over the escalating expenses of the Ayd Mill Road project. It seems to me that the best course of action would be to return to the original plan of simply resurfacing the existing roadway. I fail to see the need for a bikeway in that corridor, especially considering the added expense that would incur. And there are so many other streets that need desperate attention, for example Summit Avenue between Victoria and Fairview, and Victoria north of Summit. The condition of those roadways is deplorable! I drive them often as I live just east of Victoria on Laurel and it feels like my car is being slowly damaged by the potholes that have been patched too many times. And I am ashamed that the runners of the Twin Cities Marathon have to endure the surface of Summit each fall.

I have lived in St. Paul since 1982. My wife and I purchased our first home in about 1985, then bought the Laurel property in 1992. I went back and looked at my property tax statements for the last nine years, just to get a sense of the increases that have happened. The market value of my house (as determined by the county) has gone up about 20% since 2011. The amount of my property taxes for St. Paul have increased more than 50% in that same period of time while inflation has remained quite low. And during most of that time, street maintenance fees were a separate bill. I don't believe we can really afford high end projects when the basics are in shambles, and that is the case based on the reports of the city's own departments.

I am now retired and living on a fixed income. I really like living in the city and have never minded contributing to what I think is a good quality of life, but lately it seems we are getting less and less of a return for the investments we are asked to make. And now in addition to the property tax increases, there is going to be a request for a sales tax increase, which is a regressive tax that disproportionately impacts lower income people.

Is this really the best we can do?

I am not convinced that the reconfigured road would result in increased vehicular traffic on neighborhood streets, while a three-lane road with a pedestrian and bike way is a significant improvement over the current road and moves us in the right direction away from Ayd Mill becoming a full interstate connection. Good morning, Councilmember Noecker,

With the recent budgetary bad news, I feel the need to write you again regarding Ayd Mill. Previously, I was in favor of either do nothing, or the Mayor's plan to turn half of Ayd Mill into a bicycle and walking multi-use path.

With the latest budget numbers, I think the calculus has changed. That's an awful lot of money for a plan that, as I understand it, only buys about a decade until the entire road needs to be essentially replaced.

It's time to rip off the band-aid. There is no possible way Saint Paul can afford the full replacement in a decade, and it's foolish to throw \$10 million good dollars after bad on that road now. If Saint Paul can't afford a \$100,000 fireworks show, it can't afford this pathway to Dakota County. I'd ask you to recommend to the Mayor that he do a reverse Randy Kelly, and just send public works out to close it late one Friday night. Either that or put up signs that Ayd Mill is now considered a minimum maintenance road, and drivers can enter at their own risk. After posting those signs, just stop all maintenance, snowplowing, etc. No Saint Paulite lives on that street, so it's of little concern to any of us if it falls apart.

After closing all of Ayd Mill to vehicular traffic, the conversion to a multi-use path should be far simpler, less expensive, and able to be completed over time. I understand it would also likely qualify for federal funding.

In other news, my partner and I are excited to be investing in Railroad Island. We'll be building a new Work/Live office/house on Payne Avenue as it runs through the Island, and relocating our company. I think it will be only the second Passivhaus built in Saint Paul – meeting stringent energy use requirements and with solar panels on the roof, it will be carbon negative – generating more electricity than it requires, burning no fossil fuels for heat, and eventually replacing the carbon it took to construct the house. Construction is slated to begin in spring of 2022.

Councilmembers Tolbert, Jalali, and Noecker:

I am writing you again today to express my support for a meaningful transformation of Ayd Mill Road into a bike/ped trail. The recent news of ballooning costs for maintaining auto uses on AMR show how quickly it can drain our citywide streets budget if it is focused on moving autos instead of providing a safe and high-quality trail connection. As a resident of Ward 3, I have no interest in keeping cars on Ayd Mill, and certainly not in three of the four lanes. Please focus street repairs and safety improvements on our neighborhood streets, not on an urban freeway that doesn't generate value for our community.

Rather than implementing a more expensive, auto-oriented improvement, the council should consider closing the road immediately. I was told in 2019 (below) that Ayd Mill needed funding because it was not safe for driving or even for city staff to repair due to the paving condition. Facing that situation, why not close it? The road was closed for many years, and only reopened as a "test condition" without council approval. Is it so unimaginable to consider closing it again for a period?

I recognize that the council has concerns about traffic spilling onto local streets. Instead of being driven by fear and speculation, a closure period would allow staff to collect actual data on traffic changes. If local street traffic calming is deemed necessary, it could be meaningful and strategic.

As I noted almost a year ago in my March 2019 email below, closing Ayd Mill won't be easy now, and it certainly won't get easier the longer you wait. Please consider deferring this auto-centric design and close AMR until the City can present a cohesive, informed vision that is consistent with the recently-adopted Climate Action Plan.

Dear Councilman Tolbert and Council President Brendmoen,

I have been a St Paul resident for 35 years living in MacGroveland. I live between Snelling and Ayd Mill Rd so am very aware of the history of Ayd Mill. I **strongly oppose** plans to reduce the roadway to 2, or now 3 lanes. I oppose it for a number of reasons:

- Yes, Ayd Mill is in need of major repair, if not reconstruction. It serves a much needed artery to move traffic <u>through</u> the neighborhood, not <u>into</u> the neighborhood. It also serves as a valuable artery for moving residents of St. Paul to work and to locations for other life needs in the south metro (it is not only used by suburban commuters!)
- The logic of the proposed changes just aren't there without more study/statistics to demonstrate that reducing lanes will reduce auto use or that a bike lane and pedestrian walkway would be used enough to merit pushing traffic into the neighborhoods. (Simply reducing traffic lanes will not automatically insure drives will go out of their way to find alternate routes that aren't on city streets.) Especially with the increased cost of the current proposal this would be a short-sided and poor investment of taxpayer investment.
- I am a biker, as well as an auto user, so I understand the desire to have a bike lane, but not at the expense of the traffic lane reductions. In the past, there was a plan or study that said there was room for a bike/pedestrian way along that stretch even with the four-lane roadway. Why has that not been considered? Could that not be added when funding is more available?
- I hate to say it, but St. Paul residential streets are an embarrassment. We need to be investing in real street improvement instead of cutting everything short and only patching

pot holes year after year (And, pot holes on my street weren't repaired last year until Sept.!). I grew up on a farm and drove on field roads that were better than many residential streets here. Over my years in St. Paul I have seen a gradual decline and neglect of decent street maintenance and reconstruction. We are about at a point of no return. I understand Ayd Mill is city funded, but why not at least explore making it a county or state artery that would make it eligible to be tapped for county or state transportation funding?

I believe that moving ahead with the proposed plan, especially with the significant additional cost added to the proposal, would be a poor decision. Fix the current four-lane Ayd Mill Rd artery and keep the traffic moving through, instead of into, the neighborhood. Add bike and pedestrian access as real statistics merit that addition and funding is available.

I strongly oppose the current proposal and urge you to consider opposing it as well.

I am strongly opposed to the plan to reconstruct Ayd Mill road with significant cost for pedestrians and bikes. You politicians continue to ignore the reality of the low percent of people who walk or bicycle

and bicycling is only a viable mode of transportation for all but a few hardy fools for about 6 months of the year. To spend large sums of money for the benefit of the few is irresponsible and not fair to the tax payers.
