I write to express my concern regarding the approval for Lutheran Seminary to expand a parking lot at 1465 Branston Street.

The area in dispute is across a dead-end street from a lovely pocket park affectionately called Monkey Island by those of us who live by the park. For decades (as long as anyone can remember) that little park has been a safe play area for small children as there has not been much traffic around the park. The importance of the park to this community was demonstrated several years ago when the playground equipment was getting old and needed to be replaced and the community raised the funds for new equipment.

Several features of an urban neighborhood that make it attractive to families is the feeling of community and safety. A shared play space where children and their parents (and grandparents and other caregivers) can meet, watch their children play and get to know each other is a critical component of that model. Dear Mitra:

I am writing regarding a proposal by Luther Seminary to expand a parking lot at the south end of Branston Street.

My interest is as a long-time neighbor on Grantham Street, but more directly as one who helped lead the successful effort to renovate the playground, known in the neighborhood as "Monkey Island" in 2013. As Mike Hahn can attest the playground was close to being eliminated because of obsolete and unsafe equipment.

The neighborhood and St. Paul Parks and Recreation worked together to create a first-class playground that is used by the children in the neighborhood.

I am concerned that the increased traffic on Branston Street from the expanded parking lot is going to be a risk to children who cross Branston Street to use the playground. Branston is a narrow street that is not designed to handle increased traffic and the playground is at the top of a rather steep hill.

The Saint Anthony Park Community Council recognized the potential risk to the children when it conditioned its approval of the parking lot with the caveat that Luther Seminary "limit traffic from the lot and slow traffic on Branston."

I am troubled that this condition is not included in the final approval by the city. My fear is that the Seminary will not take actions to limit traffic unless directed to by the City.

My request is that the expansion of the parking be conditioned by a requirement that the Seminary take specific actions to accommodate the traffic concerns expressed by the Community Council.
