Can you send this to ADS to investigate? Resident owns a 4 plex in St Paul. Should be services under the citywide contract. He has 4 city carts at the property. Republic is the provider in this area. He also has an Advanced disposal dumpster at the property and has been paying for service this entire time. You can see the payment history in the attached document.

Has ADS been servicing this dumpster and 4 plex? They should not be as this is not their service area.

Secondly, we need to have ADS pull the dumpster so the resident starts to use the 4 bins that they have at the property. Can you have the dumpster removal scheduled?
