On the nights of 05.31.19 and 06.14.19, I was working details that focused on the area around University and Hamline. This detail was created to address ongoing calls of fights, open-air drug dealing, weapons violations, and aggravated assaults.

On 06.01.19, two people were arrested leaving the BP gas station (1347 University) with a firearm. During an

interview, one of the people said she chose to go to this gas station because she knew she could by single cigarettes there. She also said she bought single cigarettes on this night.

19.115.394

Also on 06.01.19, two volleys were fired near Hamline/University. Casings were recovered in front of 1354 Sherburne. These were fired in the direction of a group of cars that had just left the gas station. The second volley was fired from a vehicle that fled WB University from the gas station. No casings were recovered from that volley, but I overheard the shots being fired via my radio.

On 06.15.19, a man walked from the gas station (SB) to the parking lot directly south of there. He got into a van with another person and purchased drugs. Subsequently, the men were stopped on traffic and cited for possession of marijuana in a motor vehicle.

19.128.132

Also on 06.15.19, I saw two men walking around and transferring a firearm that had a high capacity magazine; they were in between the pumps at this gas station. At one point, I saw the men notice something to their NW (Hamline entrance of the parking lot). The man who had the gun at that time stopped what he was doing and grabbed the grip of his pistol. It appeared to me that he recognized a threat and was preparing to address it. Then he took his hand off his gun and continued hanging out with his associates. Subsequently, the men were arrested for DWI and weapons violations.

On both nights between 0200 and 0330 hrs, I could see 20-30 cars in the parking lot. There was no room to move; I could not see the north or west sides of the building. Cars were driving through the lot, but they were bumper to bumper. I observed hand-to-hand drug transactions, people drinking alcohol, and people smoking marijuana. There were groups of over 100 people standing around in the parking lot, dancing, and there were fights. At no time did I see anyone working security in the parking lot, but I did notice the store employees controlled access to the store. It looked like they only allowed a small number of people in the store at one time. Many of the cars that parked at the pumps did not purchase gas. Most people who were in the lot never entered the store.

Then I went back and viewed CCTV footage from May 11, 18, and 25. Many of the aforementioned activities also occurred on these nights.

I submitted a request for the Technology Unit to recover video from these times.
