NARRATIVE

No ICC Squad 1784

BWC Ofc Gliske/ Lacska was active during this call and was not reviewed prior to this report. The following is a summary of events and not to be taken as transcript.

On 8/31/2018 at around 0228 hours Squad 110 Gliske/ Lacska were sent to the BP 1347 University Ave W on a report of shots fired.

The comp stated they heard 12 shots from the parking lot and two vehicles leave north bound Hamline Ave.

Several other callers called in stating they heard several shots from 6 to 12 shots in the area.

We arrived on scene and went north to see if we could locate the vehicles. As we drove past the BP we saw several people in the lot. One male later identified as security of the BP: Jonathan Leandrew PAIGE (DOB 12/14/1985) was using his flashlight looking at the ground and under vehicles. I also saw him with several other people at the rear of an open trunk of a large Black Tahoe.

We were not able to locate any vehicle so we went back to the BP to check for evidence,

We spoke to PAIGE who changes his story a few times and acted cagey when answering questions. He stated he was security for BP and said nothing was going on. He stated no one was shooting in the lot and said it might of been north or in the alley. He later stated he never heard or saw anything and he was inside the whole time.

I spoke briefly to one of the comps who is a security guard at 1305 University who stated PAIGE lied to me and he knew what was going on. He also stated he thought he was picking up casings.

Squad 114 Ofc Manson/ Mohn spoke to him, see their supplement.


I checked the lot for evidence with negative results. I went back to talk to PAIGE who again acted shady and then said he was off the clock and left abruptly.

I spoke to the teller: Carlos MAURICIO (DOB 1/26/1969) who stated he never heard or saw anything. He stated PAIGE was inside and didn't see anything either. He stated he was busy with customers and knew nothing. I asked if he knew how to work the cameras and he said no. I told him to get a hold of someone who did and I spoke to a manager on the phone who said he would text CARLOS the password so I could use the cameras.

The password he sent was wrong and I was never able to get footage.

I asked CARLOS about PAIGE and when he normally left. CARLOS never really answered the question and showed me his timecard which showed he left at different times every night.

Squad 125 Palkowich stated on CCTV camera shows a black Infiniti SUV and a Purple Impala with large rims as the ones involved. He stated the camera does not show the shooting or the lot just the vehicle as they are
