## NOTICE OF CONDEMNATION UNFIT FOR HUMAN HABITATION ORDER TO VACATE

RE: 2002 BUSH AVE Ref. # 125012

Dear Property Representative:

Your building was inspected on December 9, 2019.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

The following deficiency list must be completed or the building vacated by the re-inspection date.

## A reinspection will be made on or after March 10, 2020.

## CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

## **DEFICIENCY LIST**

1. Interior - Throughout - SPLC 34.23, MSFC 110.1 - This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.-The building has been condemned due to but not limited to extensive smoke and fire damage throughout the second floor.

- 2. Interior Throughout SPLC 34.12 (2), SPLC 34.36 (1) Repair and maintain all required and supplied equipment in an operative and safe condition to properly and safely perform their intended function in accordance with the provisions of the applicable code.-There were multiple smoke alarms throughout the building that were sounding with a low battery alarm.
- 3. Second floor Throughout SPLC 34.10 (7), 34.17 (5) Repair and maintain the walls in an approved manner.-Repair fire damaged walls throughout the second floor.
- 4. Second floor Throughout SPLC 34.10 (7), 34.17(5) Repair and maintain the floor in an approved manner.-Repair fire damaged flooring throughout the second floor.
- 5. Second floor Throughout SPLC 34.10 (7), 34.17 (5) Repair and maintain the ceiling in an approved manner.-Repair the fire damaged ceiling throughout the second floor.
- 6. Second floor Windows SPLC 34.09 (4), 34.33 (3) Repair and maintain the window in good condition.-Repair or replace the fire damaged windows.
- 7. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
