The Department of Safety and Inspections will recommend denial of the Taxicab Driver license application submitted by Steven Joseph Asmussen for the City of Saint Paul. The recommendation is based on the following information:

On August 21, 2019, you submitted an application for a Taxicab Driver license with the Department of Safety and Inspections. During a routine criminal history check as part of the application process, DSI discovered you were convicted of 3 Speeding violations on June 2, 2016, March 1, 2017, April 10, 2017 in Ramsey and Hennepin County. Also, On May 5, 2017 you were convicted of failure to over traffic-control device and On May 30, 2017 you were convicted of improper change of course or failure to signal lane change in Ramsey County.

Saint Paul Legislative Code § 376.15(e) 4 (c) states the basis for adverse action: "For original licensure: No more than four (4) moving violations within the last three (3) years, and no more than two (2) moving violations in the last year. For renewal: No more than four (4) moving violations within the last three (3) years and no more than three (3) moving violations in the last year. A moving violation means, for this subsection, a violation of a traffic regulation but does not include a parking violation, vehicle equipment violation, or warning citation."

At this time, you have three (3) options to proceed:

- If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by Tuesday, March 3, 2020. I will presume that you have chosen not to contest the proposed adverse action, and the matter will be placed on the next available City Council agenda for approval of the proposed remedy.
- 2. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **Tuesday, March 3, 2020**. The matter will then be scheduled before the City Council for a public hearing to determine whether to deny your Taxicab license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. If you dispute the facts outlined above, or wish to present evidence that the conviction is not related to your license as a Taxicab driver, or that you have been rehabilitated pursuant to Minn. Stat. §364.01 et seq, you may request a hearing before an Administrative Law Judge (ALJ). I will need to receive your letter no later than **Tuesday**, **March 3**, 2020. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

Please note: If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing per Saint Paul Legislative Code § 310.05 (k).

If you have not contacted me by Tuesday, March 3, 2020, I will assume that you do not contest the denial of your Taxicab Driver license. In that case, the matter will be placed on the next available City Council Consent Agenda for approval of the recommended penalty.
