Okay so I had to request that the 10.5.19 invoice be sent to my home computer and then I had to forward it to my work computer.

So the billing consists of service from 12.1.2018 to 9.30.19 (the \$248.17) then the billing for Oct to Dec 2019 (\$74.37) plus tax.

So that bill is for a total of \$444.30 plus you add on 3 months of late fees 22.22+22.21+22.21 the total bill is \$510.94 which was sent to collections.

I show on a spreadsheet back in Dec 2018 or so a notice of change of name and address to Gold Path and at no time on any of the spreadsheets since then did I notice a vacancy notice for the property.

I don't know if the reason I finally set up a new account for Gold Path was because they called in Sept 2019 and I got an e-mail from customer service about them calling or if it was because the old owner had finally called in to have her account canceled.

Either way after doing some research and not seeing anything on the city spreadsheets I set up the account as of 12.1.2018.

If as they say – they were occupied as of 10.1.2019 – did they not receive the 10.5.2019 invoice and the three past due notices for that timeframe.

Plus we certified \$114.34 for 1st Qtr 2020 – they didn't receive that invoice either or the three past due notices we mailed out.

Again they never called – until they contacted the city.
