At this point all I know is that we delivered him another 32 gal trash cart in early Nov.

We don't have any pictures or comments from the driver prior to 11.4.2019.

The serial number on his 64 gal trash cart was 00818822672 and I can't find that we delivered that one anywhere else after 1.10.19. For all we know one of his neighbors could have it.

So again I say, why did he wait until October to state he didn't have two carts. Ramsey County states it is a rental with "homestead status" and his mailing address is the service address – so he lives on site. It's not like he was a landlord that didn't live close by and one of the tenants finally stated something months later.

He also paid us in full for 1.5.2019, 4.5.2019 and 7.5.2019 Billings – but didn't pay us for the 10.5.2019 billing (note he had called us about the issue in Oct) and he paid the 1st Qtr 2020 Billing. Seems strange to me that you would pay for the first two quarters in full when you were missing a cart.

The serial number on the 32 gal we dropped on 11.4.2019 is 9184654.

At this time I am willing to reverse the 3rd Qtr assessment of \$161.77 that was sent for certification (I see it hasn't hit his taxes yet) and call it done.

I show that the city delivered him a 32 gal trash cart (00071868008) and a 64 gal trash cart (00818822672 – note not a 96) in late summer.

He called our office on 1-2-19 asking us to remove the 64 gal trash cart and to deliver a 32 gal trash cart. Tickets were put in and everything looks like we did what he asked at the time.

So, if you hadn't gotten the other 32 gal trash cart – and we had taken one away – wouldn't you have called us back – let's say within a week.

He waits until late October to call about this issue!!!!!. He actually called us in April to have his billing information updated and he never once mentioned anything about a missing cart.

So we finally did deliver him the other 32 gal cart on 11.4.19 serial #9184654.

Now I know this is a duplex – because I was thinking that maybe his tenants didn't say anything to him until now. But it is marked as a duplex with residential homestead – so he must live in one of the units.

So how can he justify asking for a basically one year credit and he didn't call about it until Oct.

By the way – the original agent he talked to told him he could do a credit for \$153.18 – he turned it down – said it wasn't enough (not sure where the agent came up with that one)

If we would give him a one year credit – I only come up with \$102.98 – because we were billing him for 64 gal trash cart – not a 96.
