Re: Making Finding the Order to raze and remove the structure at 718 Orange Avenue East

Dear Mr. Nord & Ms. Guild:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant 180 days on November 13, 2019 for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **May 12**, **2020** at **10:00** a.m. via telephone at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If you received the Certificate of Code Compliance by May 12, 2020, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received the Certificate of Code Compliance by May 12, 2020, you will need to contact Joe Yannarelly (<u>joe.yannarelly@ci.stpaul.mn.us</u> or 651-266-1920) to schedule an inspection to occur *prior to* the week of May 12, 2020. Both Mr. Yannarelly and a building inspector will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, May 20, 2020 at 3:30 p.m. remotely. You may submit written testimony to CouncilHearing@ci.stpaul.mn.us or call 651-266-6805 as in-person testimony is not feasible at this time.
