This letter is in response to Mr. Yust's email to Councilmember Rebecca Noecker dated March 17, 2020. Councilmember Noecker discussed Mr. Yust's request with Legislative Hearing Officer, Marcia Moermond. On May 5, 2020 at 9 a.m. at your scheduled Legislative Hearing, Ms. Moermond will recommend that if the project is completed by July 8, 2020 (the date of the conclusion of the 180-day extension to complete the rehabilitation), she will recommend that the Council delete the assessment. This recommendation will be put into the record without you needing to be present. If you have additional information to be added to the record, please use the hearing as an opportunity to do that.

The City Council will consider the vacant building assessment June 17, 2020. At that juncture, Ms. Moermond will ask the City Council to continue the public hearing to **July 22, 2020 at 3:30 p.m**. at which time she will recommend deleting the assessment if the project is completed and a Certificate of Code Compliance has been issued.
