- 3. 1st Floor Living Room SPLC 34.10 (7), 34.17 (5) Repair and maintain the ceiling in an approved manner.-Crakes in the ceiling
- 4. 1stFloor & 2nd Floor Living Room, 1st & 2nd Bedroom MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area.- Smoke detectors are not working
- 5. Exterior Front SPLC 34.09 (2), 34.33 (3) Provide and maintain foundation elements to adequately support this building at all points.-Large cracks on the front of the house.

- 6. Exterior Garage SPLC 34.33 (3) Repair and maintain the door in good condition.-Garage door is chipped and peeling paint.
- 7. Exterior Multiple Location SPLC 34.09 (4), 34.33 (3) -Provide or repair and maintain the window screen.-Torn Screen and missing.
- 8. Front Door & Rear Door SPLC 34.09 (4), 34.33 (3) Repair and maintain the window glass.-Broken Payne and Missing.
- 9. Interior SPLC 34.19 Provide access to the inspector to all areas of the building.
- 10. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
- 11. Sec. 40.06. The fire code official may, in writing, issue a notice to the owner(s) and known interested parties of the city's suspension or revocation of a fire certificate of occupancy issued under the provisions of this code, or deny an application therefor: If the owner, in a material matter, fails to comply with the regulations in section 40.09 of this chapter; or in situations where the fire code official after a good faith effort cannot identify an owner or interested party.-Property has been revoked due to non-compliance of fire and life safety deficiency by the property owner or responsible party.
