I do not understand this message. Is part of the meeting on the 3rd and continuing on the 10th or is my meeting cancelled on the 3rd and re-scheduled on the 10th?

I would appreciate my emails to be read from May 28th, even though there is anger and frustration behind my message.

In addition, let it be known, doors that are not used can be locked on the inside with a skeleton key. When I am not working on the project, pre-prepping the wood and painting - tall planters block the steps, so people do no use the area under construction. I feel my home has taken all safety precautions. Everything is finished, regarding the balcony/steps - just waiting for the railings. The bottom railings are finished. I requested both stories to be installed at the same time. Regarding my back yard, the lawn is mowed by a professional service and I try to maintain the back, when I can. My first priority is the balcony. The rest of the area, in my mind is minor - there is an area of black dirt snd a few people have said they will take some away for their gardens. In the meantime, the area is covered. In my mind, when the balcony is finished, any minor areas, where weeds need to be picked is not enough to keep any problems on going. Eventually, a landscaper will be hired to plant bushes and re-grade. I can only work on one project at a time.

My home is my pride and joy. My intention is to upkeep my home to look like a palace. Over decades, i have continually made upgrades. I realize people have complained - as my next door neighbor said - "people have nothing better to do in their lives" - which is very sad. My neighbor across the street has apologized, though her complaint has caused a riff, because the city has attacked me unfairly. Not what I expect when living in Mac Grove. Hopefully, the city will promote kindness and help the community, instead of attack their residents.

I had a contractor cancel a contract, possibly because negative comments within the city. When the virus is gone, I plan to look into this matter. This caused further delays, which did not benefit either of us.
