I am writing to the Commissioners regarding the proposed designation of JO Companies, LLC as tentative Developer for the property at 520 Payne Avenue. My name is John Belpedio, resident at 536 Payne Avenue. There are multiple reasons not to move ahead with a residential high-density housing complex at this location.

I can list the reasons, why this project should not move ahead - including the safety of Seventh and Payne; The intrusion of the Fire Station across the street; the lack of adequate playground and access to educational facilities; consideration of the flightpath of aircraft from Holman Field; the proximity of a multi-family housing apartment complex to a nightclub; inadequate parking for the number of units being proposed; and the dangerous entrance and egress off of Payne avenue for motorists.

I could go on. However, I would like to request that the HRA Board of Commissioners strongly consider postponing this decision until a public hearing is held where the neighborhood and interested community members can voice their concerns.
