

Revocation of Fire Certificate of Occupancy and Order to Vacate

Dear Property Representative:

Your building was inspected on May 26, 2020, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

A reinspection will be made on June 29, 2020 at 1:00PM or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. SPLC 40.06 Notice of Pending Revocation.
 - -Pending revocation due to long term non-compliance. Comply with existing orders by 6-29-20 at 1:00 PM or property must be vacated.
- 2. Back Porch MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.
 - -Back porch will filled wall to wall with items.
- 3. Exterior SPLC 34.09 (1)(2), 34.33 (1) Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint.
 - -SW retaining wall in the backyard is falling into the back yard. Repair the wall in an approved manner.

Update 12/2/19 inspection: No work completed. Per the Council resolution 7/24/19, work was to be completed by December 1, 2019. Transferring to C of O for enforcement action. 4/21/20: update no work is done on rear retaining wall. 5/26/20 no progress on

rear exterior wall. Material appears to be purchased and permit is in the process of being pulled.

4. SPLC 39.02(c) - Complete and sign the smoke detector affidavit and return it to this office.
