Dear Ms. Orr, Mr. Stuff, & Dr. Mohamud:

Legislative Hearings were conducted before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant 180 days for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for Tuesday, June 23, 2020 at 10:00 a.m. (via telephone as in-person hearing is not feasible at this time due to Covid-19 health pandemic) at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If you have received your Certificate of Code Compliance by June 23, 2020, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received your Certificate of Code Compliance by June 23, 2020, you will need to contact Joe Yannarelly (<u>joe.yannarelly@ci.stpaul.mn.us</u> or 651-266-1920) to schedule an inspection to occur *prior to* the week of June 23, 2020. Both Mr. Yannarelly and/or Building Inspector Nathan Bruhn will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, July 8, 2020 at 3:30 p.m. remotely or you may send in written testimony to Councilhearing@ci.stpaul.mn.us or call 651-266-6805 to be attached to the record. (If this changes, I will let you know)
