NOTICE OF CONDEMNATION UNFIT FOR HUMAN HABITATION **ORDER TO VACATE**

Dear Property Representative:

Your building was inspected on June 10, 2019.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

The following deficiency list must be completed or the building vacated by the re-inspection date.

A reinspection will be made on or after July 10, 2019.

CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

- 4. House SPLC 34.10 (7), 34.17 (5) Repair and maintain the walls in an approved manner.-Repair or replace the damaged or deteriorated wall coverings. Patch the holes and/or cracks in the walls.
- 5. House SPLC 34.10 (7), 34.17 (5) Repair and maintain the ceiling in an approved manner.-Repair or replace the damaged or deteriorated ceiling. Paint the ceiling. Patch the holes and/or cracks in the ceiling.
- 6. SPLC 34.11(5), 34.35(2), MPC 408.3 Provide adequate hot water between 110 degrees F and 120 degrees F.-
- 7. SPLC 34.11(4), 34.35(1), MPC 601.1 Provide an adequate water supply to all water closets, sinks, showers and tubs.-
- 8. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
