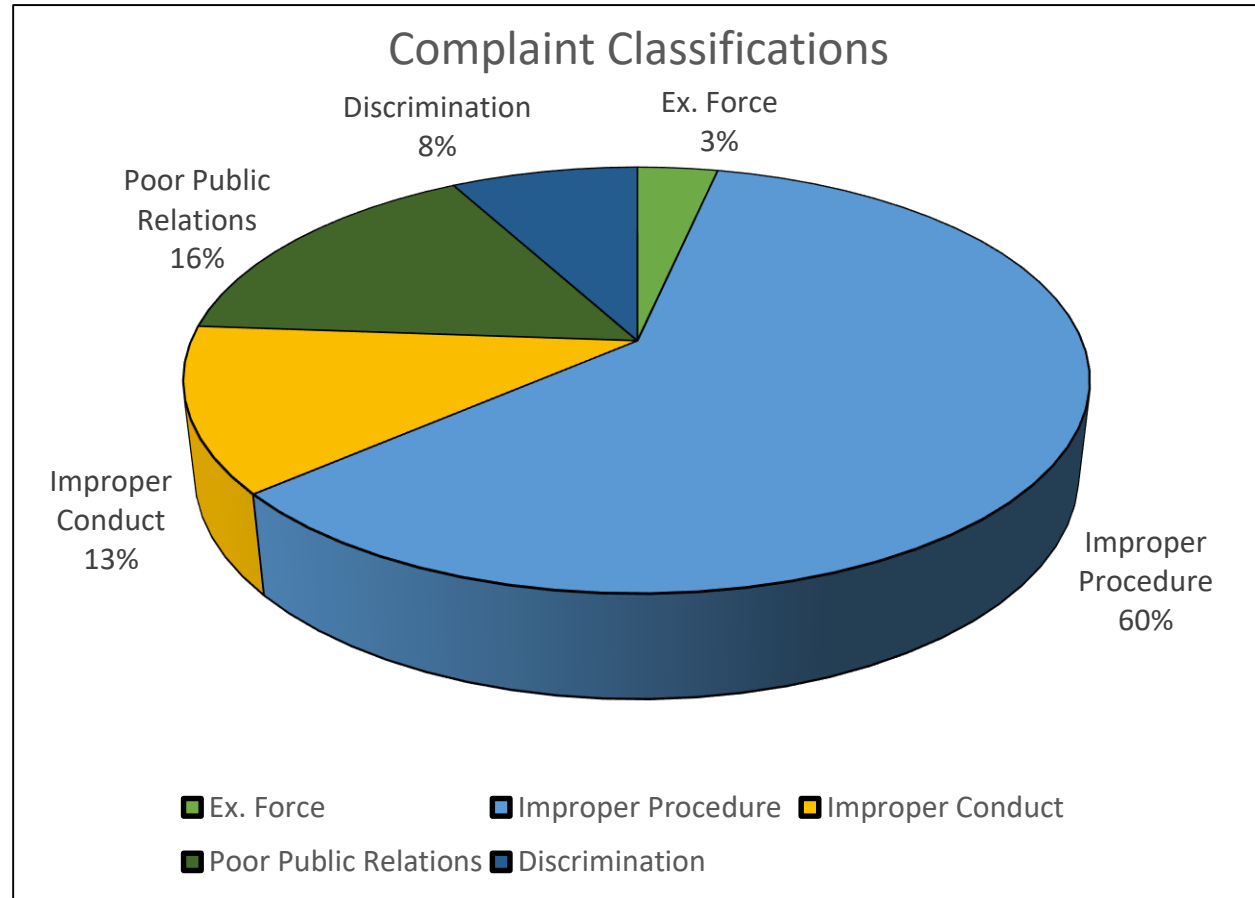

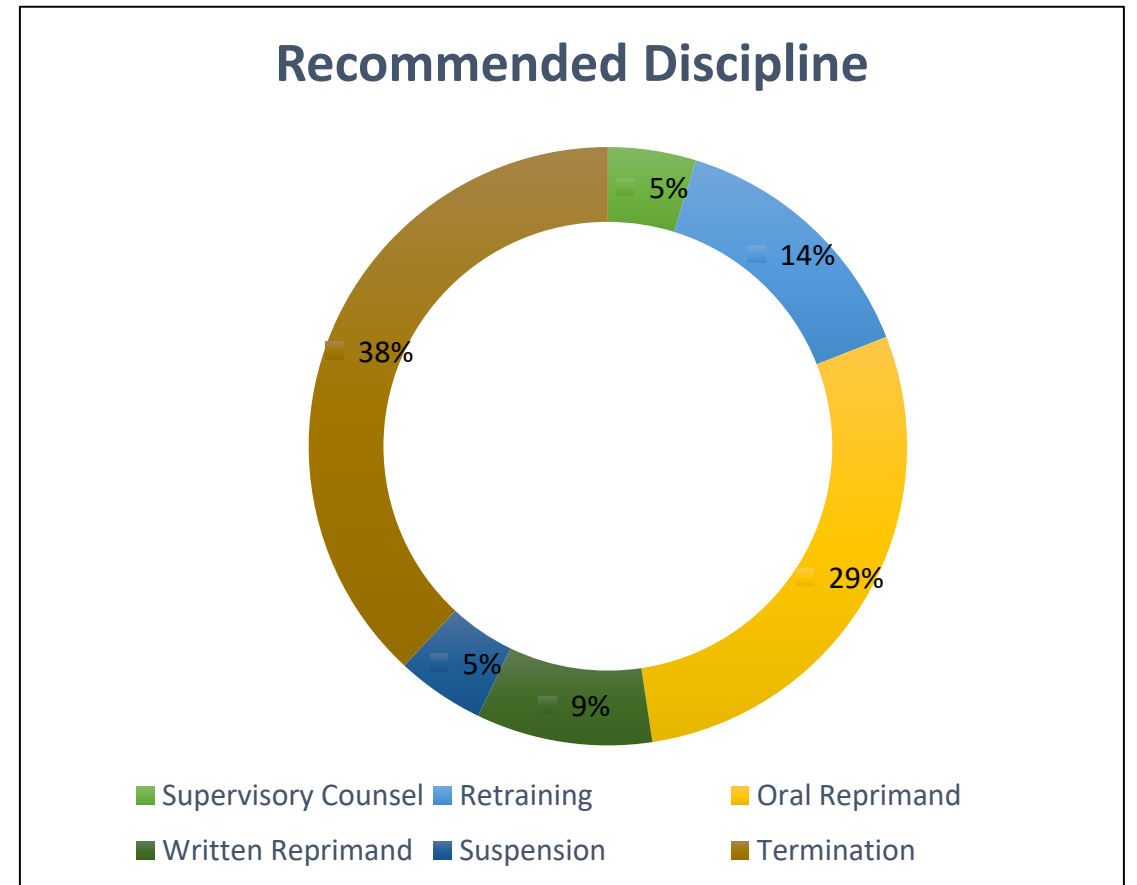
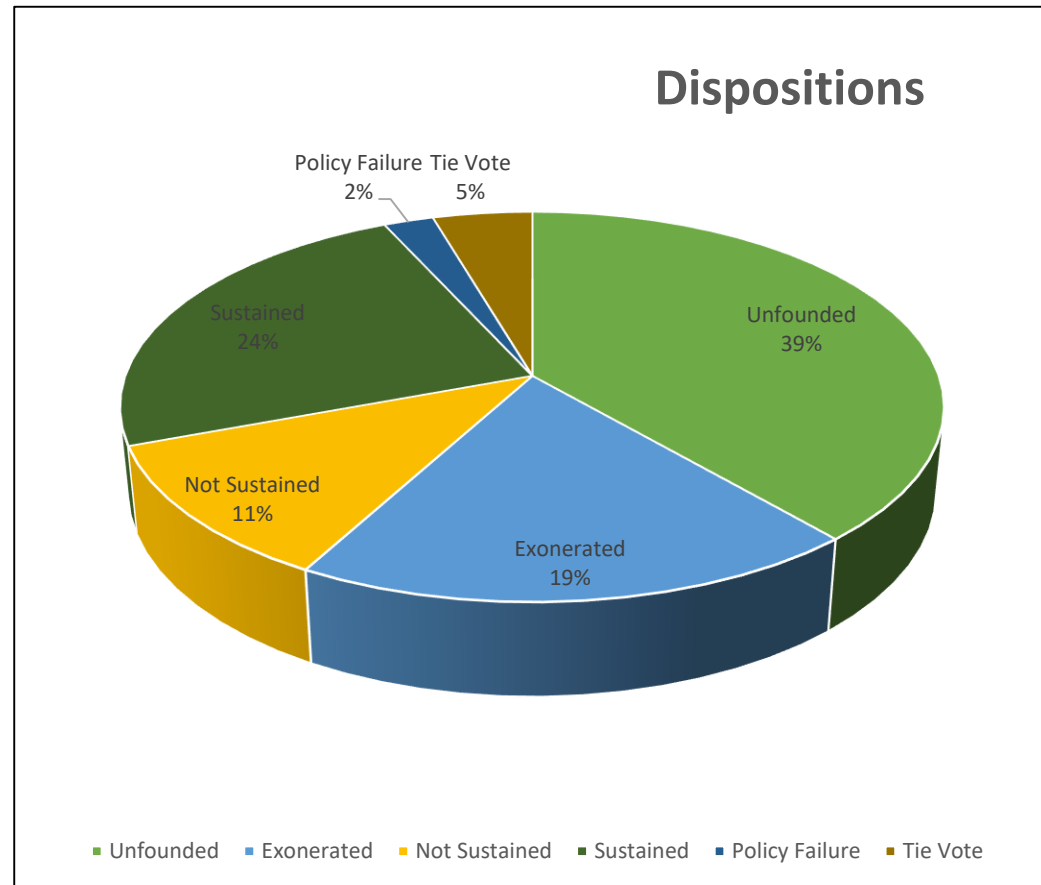

- Policy Research and Recommendations Committee
  - Assist in research, and review efforts for policy change recommendations based on trends of complaints, and concerns brought before the commission.
- Community Outreach and Engagement Committee
  - Assist in implementing the outreach plan, promotional strategy, event planning and identify populations that are underserved to connect with.

# Future Plans

- Annual Summit
  - Originally scheduled for the spring and postponed due to COVID-19. The PCIARC will hold a virtual 2020 Annual Summit informing the public of their work during 2019 calendar year, and sharing summary data, and releasing the 2019 Annual Report in the Fall.
- Youth Townhall
  - PCIARC will host a youth round table that will focus on connecting better with the youth of Saint Paul, and informing them of the PCIARC. The PCIARC will be gathering feedback from youth participants to better engage our youth.
- Limited English Proficiency Summit
  - PCIARC is partnering with the Accessibility Coordinator and will hold an informational targeted at our LEP population. The goal is to get more interaction from our non English speaking community, and strategize on how to bring them more into the process.
