Managers' IS undergoing a culture shift

A culture shift is happening at SPRWS. Adaptability. The definition from Webster's dictionary defines adaptability as a noun, meaning: the trait that allows something or someone to change according to need or environment. In today's world of Covid-19, civil unrest, and other important issues, adaptability reflects being adaptable, an action verb. (A word that expresses action.)

So how does that change what we are doing today at SPRWS?

Traditionally, IT technology governance, initiatives, solutions, and decision-making have been the responsibly of the IS department. However, over the past several years, there has been a shift from IS ownership to an ownership more toward customers.

This change is happening today at SPRWS. We are implementing a formal Technology Governance structure using industry standards and best practices based on the principles behind Control Objectives for Information and Related Technology. This helps organizations meet business challenges in the areas of regulatory compliance and risk management while aligning IT strategy with organizational goals.

We have several technology teams that have roles and responsibilities in this effort. These teams include the Executive team (E-team), the Cross-Functional team (CFT), which is made up of staff across the utility, and the Technical Advisory Team (TAT).

The focus of Technology Governance is to:

• Develop a consistent and sustainable program for technology.

Board of Water Commissioners reviews budget, rates for 2021

The Board of Water Commissioners reviewed the proposed budget and water rates for the 2021 fiscal year at its July 14 meeting.

Staff have been working on the budget extensively this spring to present to the board for their consideration.

"The proposed budget continues our practices of funding all of the necessary resources to ensure all the operations and maintenance needs of SPRWS are met and the funding necessary to continue our investment in our system in accordance with our 10 year capital plan," said Steve Schneider, general manager.

It will also include an issuance of debt that will fund the first part of the construction activity for the McCarrons treatment plant improvement project.

The board will review the proposal and hold budget workshops this month.

The 2021 proposed budget and water rates will be discussed during a public hearing on Sept. 8 before the board votes on whether to recommend the budget to the city council for adoption.

If recommended for approval and approved by the council during a series of council meetings, the proposed budget will go into effect on January 1, 2021.
