**Back bill:**

Billed: \$160.13

**Q4 2019:**

Billed: \$198.52

Size: 95gal

Billed: \$74.37 (base rate) plus taxes

Total with taxes: \$102.44

Size: 68gal

Billed: \$69.75 (base rate) plus taxes

Total with taxes: \$96.08

Total: \$102.44 + \$96.08 = \$198.52

Late fees: \$0.00

Total certified: \$0.00

Payment from Customer: \$358.65 on 10/11/2019

**Q1 2020:**

Billed: \$384.66

Size: 95gal

Billed: \$72.18 (base rate) plus taxes

Total with taxes: \$99.43

Size: 68gal

Billed: \$67.56 (base rate) plus taxes

Total with taxes: \$93.07

Total: \$99.43 + \$93.07 = \$192.50

Late fees: \$11.32 X 3 late fees = \$33.69

On Q1 2020: The system billed the 68gal trash cart from July – December (2 quarters)@

\$139.50 plus taxes (\$69.75 + \$69.75) = \$192.16

Making the Q1 2020 invoice \$384.66

Credits: \$192.16 (\$192.16 - \$384.66 = \$192.50)

This being said the late fee will need to be adjusted from \$33.69 to \$9.62 X 3 = \$28.86

Total certified: \$192.50 + \$28.86 = \$221.36
