Your building was re-inspected for the Fire Certificate of Occupancy on July 9, 2020. Approval for occupancy will be granted upon compliance with the following deficiency list. Theytems on the list must be corrected immediately.

A reinspection will be made on August 25, 2020 at 11:00 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. 440 University Avenue Doors to Exterior MSFC 1008.1.9.3 Remove unapproved locks from the exit doors. The door must be openable from the inside without the use of keys or special knowledge or effort.
 - Remove the barred door locking system at front door and provide a locking system that does not involve barring the door.
 - After discussion with supervisor for commercial inspections, the recommendation of appealing this deficiency to the Legislative Hearing Officer is recommended. Instructions for filing the appeal are at the end of this report.

- 2. 440 University Avenue Wall Construction SPLC 34.10 (7), 34.17 (5) Repair and maintain the walls in an approved manner.
