The water utility is seeking a water utility technician I to work at the engineering service desk within the agreements unit. This staff guides contractors, developers, residents, coworkers, and landowners through processes such as construction plan approvals, payments for new installations, assessments, land rights issues, and permitting; and thereafter prepares and routes the required paperwork and correspondence. The position is heavily involved in ongoing private developments within our service area and the ability to collaborate with public and private entities is crucial. The agreements unit authors and/or reviews agreements, legislative code revisions, water tower leases, staff reports and resolutions for action by the general manager, the Board of Water Commissioners, and the Saint Paul City Council.

Utility has internal openings for water system worker II

The water utility has four openings for water system worker II, available only to current, certified, classified employees. The positions close on Monday, Aug. 24, at 4:30 p.m.

These workers perform responsible work installing, operating, and maintaining the water distribution system. This includes water mains, services, valves, hydrants and other facilities.

They need to have one year of experience as a water utility worker II or two years of experience as a water utility worker I or equivalent. Must possess and maintain a valid Minnesota class D driver's license or equivalent. Must take a practical skills assessment, the requirements for which are listed on the city's website at stpaul.gov/jobs under internal openings for a water system worker II.

Training sessions are tentatively scheduled for Sept. 19 and 26. The exams are tentatively scheduled for Sept. 29 and 30 at Vadnais Station.

Qualified candidates will be contacted to set up their individual exam date and time.
