I am not sure why you are recommending the 2019-20 fee be ratified. Normally we have no problem getting a waiver on fire projects like this and they typically take 9 months to a year to complete. The fire was September, 2019 and we were hired in early October, 2019. We applied for a permit in November, 2019 and were not granted the permit until March, 2020. Rough-in and framing inspections were done in early June. Insulation inspection was done in July. We are within 2 months of finishing the project.
