They O Fire C of O Deficiency List/Correction were leaning up against the side of my garage which is right O Code Enforcement Correction Notice on the alley. I called the City to report this and was told an inspector would be out to look at it. <u>Charges</u>: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
