Notice: On March 31, 2020 clarification was added to the Order plainly stating, "workers supporting tobacco and vaping - product shops are not exempted." As such your tobacco products shop cannot be staffed and therefore, must remain closed until Friday, April 10, 2020 at 5:00 p.m. or as otherwise extended by Governor Walz.

• Provided technical support to other Cities within Minnesota of how to educate and enforce Governor Walz executive orders to local law enforcement and other municipalities to include licensees.
