The entire project is paid in full there is no additional financing needed. 42 inches were order but when the furnace and heating was completed 30 inches were needed. There is now a 10 week delay on cabinet orders across the country.

These delays are evident despite the manufacturer. This project for code compliance is pending kitchen install and we are just waiting on cabinets/countertops and light fixtures to be delivered to completed.

I would also like an extension on the vacant building registration which is due in 20 days. If that can't be done since it's only pending paid fixtures where labor and materials have been paid. I will consider paying them to instal something temporary if that is required by the city but hoping to get direction on that prior to code compliance registration.
