- 1. All customer and employee vehicles must be parked in accordance with and in the area shown on the dated approved site plan on file with the Department of Safety and Inspections (DSI). The total number of vehicles parked shall not exceed that shown on the approved plan.
- 2. The parking lot shall be striped and maintained in accordance with the dated approved site plan on file with DSI.
- 3. There shall be no exterior storage of vehicle parts, tires, oil or any other similar materials associated with the business. Trash will be stored in a covered dumpster. Storage of vehicle fluids, batteries, etc. shall be in accordance with the Ramsey County Hazardous Waste regulations.
- 4. At no time shall customer, employee, and/or business vehicles be parked in the driveway or in the public right-of-way (e.g., street, alley, sidewalk, boulevard, etc.).
