Dear City Council:

I am writing on behalf of new owners **Paul and Meredith Kramer** at 2183 Summit Ave., St. Paul, MN 55105 in regard to the assessment for "services" provided April through June 2020 when we (June Mendoza and Peter Herzog) were still the property owners.

This was identified as File #CG2003A1, Assessment #200139

This assessment of \$119.50 was an error on the part of Advanced Disposal – they charged us for **Residential Yard Waste** that we never requested; in fact, in 28 years at the property, we never contracted with any hauler for yard waste services.

When I called Advanced Disposal after receiving the erroneous April 6th bill, they directed me to call the City of St. Paul billing. I spoke to a gentleman at the City who said he would negate the charges (note this is during COVID when we were all working from home).

I considered it a solved problem until this assessment came via Meredith and Paul Kramer. The next Advanced Disposal bill clearly had the charge refunded, <u>but it was only on that July 6th bill</u>. They had already rolled the previous error in billing over to the St. Paul Tax Rolls on 7/2/20 without notifying us, which then caused the assessment that was sent to the new owners.

I have attached bills to show the charges and the refund on the July 7^{th} bill which should also have been applied retroactively to the April 6^{th} bill.

I will follow up this email with a call to Assessments to ensure this matter will be cleared up.
