I had been ready to send this letter.

Now that this increased revenue notice for our garbage hauling has been given, I want to send it regardless.

I was aware that this didn't have to be paid immediately and must have waited too long, somehow confused as to just how long I had. I wrote a check on October 1st which I mailed to you in the envelope provided and it was processed on October 16th from my bank.

If it were a smidge late, it was by confusion of the date due to be sure.

Two "furthermores" and some other stuff:

- 1. Furthermore.....My check is for both alley and street cleaning and lighting. I have lived here 10 years and have only witnessed an alley repair once where a truck with a bunch of guys tossed out tar in seemingly needed spots in my alley, never once witnessed it being swept and there is a light in the middle of the alley which adds greatly to our security but has been publically funded by my next door neighbor!
