Dear Mr. Chesak,

Tony, thanks for sending us a letter with information on the proposed ordinance changing the current distance requirements for 'off-sale' licenses in the city of Saint Paul.

The proposal would create additional 'wine only' off-sale licenses and these proposed 'new' licenses can be as close as 300' from an established off-sale license. I understand and agree with the MLBA's opposition to such a proposal. The addition of new alcohol off-sale licenses would seem to be unnecessary, especially with a new distancing requirement. Your letter stated that this proposal would allow four 'wine only' off-sale establishments to operate within each half-mile radius from another off-sale license. Tony, can you put a figure on how many licenses would be established? Also, where is this demand coming from? The enforced distancing laws are in force for public safety and economic freedom.

My partner, Jim Forsland, and I have been in business since 1976. We hold the off-sale license for Sharrett's Liquors. Over that period of time to the present, there have been numerous attempts to change licensing legislation (many attempts for wine in grocery stores and big-box chains, for example) continue to be proposed for changes in the law. We, in the industry, have not only been burdened with unfair competition (large liquor and grocery stores chains, Sunday sales, and questionable purchasing powers that do not exist for the rest of the industry) but it also has the effect of diminished revenue and causing the downsizing of our staff, creating the very real possibility of store closures for a family-owned and operated businesses, ours included. This may sound like 'oh pity me', but in reality, it's about time for the council to preserve and protect the long-established base of the hospitality industry from legislation that would do more harm than good. You also mentioned hearing that this has to do with the city needing additional tax revenue. Would this legislation increase or decrease revenue? We suggest that this proposal would increase unemployment and decrease

revenue, especially during the pandemic. Thus, in effect, making the cities position unacceptable. Therefore, does that mean the city would need to find an old source of revenue...Property Taxes? Ouch.

Further, we would like to explore the need for additional licenses. Our industry has seen a dramatic decrease in wine sales. The new legislation would be unfair for both established and newly created licenses. The reality is how can a 'wine only' shop be profitable and competitive and continue in business w/o the sale of spirits and malt beverages of which the latter has been increasing by leaps and bounds? The future of beer sales, with the growing number of breweries and brewpubs, will only increase. Also, top-shelf liquor sales are booming, creating shortages, rationing, and cutthroat pricing. This will also drive wine sales down further and, as can be expected, will only make these 'wine only' licenses clamoring to the council demanding full off-sale liquor licenses, and then what of the distancing requirement?.

We believe this proposal is poorly thought out and can only be detrimental to the existing business climate in our city. We have sent this email to all council members and the mayor. To all involved, we say thank you for your concern and listening to reasonable, rational opinions. Please do not pass this legislation.

Dear Councilmembers Tolbert and Prince,

My name is Luke Gulbranson and I own Liquor Village at 2289 Ford Parkway St. Paul, MN 55116 in the Highland neighborhood.

I've owned Liquor Village now a little over 8 years, it is a staple in the historic Highland Park neighborhood and has been serving the people for over 50 years. It has served hundreds of daily workers at the Ford Plant and continues to serve the ever growing and changing neighborhood.

The recent proposal regarding distance requirements that was brought to my attention brings me great frustration and disbelief. One of the reasons why I purchased my business in St. Paul was because of the requirements that the city provided with the distance between stores. The city has not allowed stores to stack up on one another like the suburbs have done. Which in turn protects small local business and keep more money in the community.

Another point I would like to raise is the issue of neighborhood safety and concern of crime increase, including underage buying of alcohol and tobacco. With more access to alcohol their will be an increase in underage purchasing and an increase in theft and robbery. In the last six months I have seen an increase two fold of theft and attempted assaults at my place of business. I do not think the current climate allows us to be short sighted about adding more high profile targets for crime such as liquor stores.

If we allow this close of proximity for liquor stores our homegrown local businesses will have to fight with big box stores like Total Wine when the inevitably come to the market. Not to mention the lack of enthusiasm surrounding the demand for more liquor stores. The current saturation levels in most neighborhoods regarding

liquor stores has already settled in with the historical supply / demand of the area. The competition between stores in most areas is already very real and robust not to mention the current regulation regarding the half-mile buffer is already encroached on when you include stores that were "grandfathered" in.

With the current proposal of a mere 300ft between liquor stores we could theoretically see them on every corner and that does not reflect the values of our small tight-knit neighborhoods. It would drastically alter the makeup of our streets and unfortunately bring more unwanted elements of crime and give the youth even much more access to tobacco and alcohol.
