Congratulations on your recent award. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) has been delegated the responsibility for ensuring that recipients of federal financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) are not engaged in discrimination prohibited by law. Awards under the Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP) will be used to develop, implement, or expand comprehensive programs in response to illicit opioids, stimulants, or other substances of abuse.

None of the following activities will be conducted whether under the Office of Justice Programs federal action or a related third party action:

1) New construction.

- 2) Renovation or remodeling of a property located in an environmentally or historically sensitive area, including property (a) listed on or eligible for listing on the National Register of Historic Places, or (b) located within a 100-year flood plain, a wetland, or habitat for an endangered species.
- (3) A renovation that will change the basic prior use of a facility or significantly change its size.
- (4) Research and technology whose anticipated and future application could be expected to have an effect on the environment.
- (5) Implementation of a program involving the use of chemicals.

Additionally, the proposed action is neither a phase nor a segment of a project which when reviewed in its entirety would not meet the criteria for a categorical exclusion. Consequently, the subject federal action meets the Office of Justice Programs' criteria for a categorical exclusion as contained in paragraph 4(b) of Appendix D to Part 61 of Title 28 of the Code of Federal Regulations.

15. SUMMARY DESCRIPTION OF PROJECT (See instruction on reverse)

The Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) was developed as part of the Comprehensive Addiction and Recovery Act (CARA) legislation. COSSAP's purpose is to provide financial and technical assistance to states, units of local government, and Indian tribal governments to develop, implement, or expand comprehensive efforts to identify, respond to, treat, and support those impacted by illicit opioids, stimulants, and other drugs of abuse.

The objective of Category 1 is to encourage and support the development of comprehensive, locally driven responses to opioids, stimulants, and other substances that expand access to supervision, treatment, and recovery support services across the criminal justice system; support law enforcement and other first responder diversion programs for nonviolent drug offenders; promote education and prevention activities; and address the needs of children impacted by substance abuse.

The Recovery Access Program (RAP) will include embedded social workers provided by People Incorporated to respond to drug overdoses where children are affected. A police officer will be assigned to RAP to assist the proposed investigator with the Naloxone Plus Model and Drug Surveillance Program. The St. Paul Police Department (SPPD) proposes to use these funds to include an investigator to act as a liaison between the police, treatment facilities, and community resources, as well as to serve as an advocate for drug courts or other measures in place of incarceration when appropriate. Funds will also be used to hire an internal SPPD data analyst to collect and manage program performance and evaluation data for the purposes of program improvement and program sustainability beyond grant funding. This project serves the city of St. Paul's population of about 310,000 individuals. The project includes partnerships with the University of Wisconsin-Madison Population Health Institute.

The Saint Paul Police Department (SPPD) is applying for Category 1: Local Applications funding in the amount of \$412,125 to further establish a Recovery Access Program (RAP) serving the City of Saint Paul, Minnesota. The RAP Program is modeled after the Arlington (Massachusetts) Opiate Outreach Initiative, which is a two-pronged approach. The first approach is an embedded social worker who connects victims of overdose with resources, and the second is education and awareness for chemically dependent individuals and their family and friends. The City of Saint Paul has a population of about 310,000 individuals and is located within Ramsey County. The RAP Program will serve the most at-risk citizens of Saint Paul and create a bridge toward services, treatment, and emergency naloxone. No other Minnesota law enforcement agency is doing this kind of work, and SPPD strives to create a template which can be replicated, like SPPD's work with mental health co-response.

The purpose of this program is to decrease overdose deaths by proactively investigating drug trends and providing resources to individuals who have experienced an overdose. The RAP Program will include embedded social workers provided by People Incorporated to respond to drug overdoses where children are impacted. A Police Officer will be assigned to the RAP Program to assist the proposed Investigator with the Naloxone Plus Model and Drug Surveillance Program. SPPD proposes to use these funds to include an Investigator to act as a liaison between the police and treatment facilities and community resources, as well as to serve as an advocate for drug court or other measures in place of incarceration when appropriate. Funds will also be used to hire an internal SPPD data analyst to collect and manage program performance and evaluation data for the purposes of program improvement and program sustainability beyond grant funding. Janae Goodrich at the University of Wisconsin-Madison Population Health Institute will be engaged in this project to provide research and evaluation support. Finally, SPPD proposes to use the funds to purchase naloxone to distribute to overdose victims who are at risk to overdose again.

SPPD's request for funding meets multiple COSSAP priority considerations:

- Qualified Opportunity Zones: The City of Saint Paul has multiple Qualified
 Opportunities, and SPPD plans to prioritize resources for the individuals residing in these
 zones.
- *High-Poverty Areas:* The City of Saint Paul has a poverty rate of 20.4% according to the American Community Survey of the Census Bureau.

3. PROGRAM NARRATIVE

The Saint Paul Police Department (SPPD) is applying to administer a BJA grant to expand the Recovery Access Program (RAP) serving the City of Saint Paul, Minnesota. The RAP Program will address the growing opioid epidemic and the overdose fatalities we have seen in the last few years. In 2019, the City of Saint Paul had 49 overdose deaths. The RAP Program will work to connect chemically dependent individuals with resources, through proactive outreach and advocating for drug court, rather than incarceration. In addition, the RAP Program will prioritize cases in which children are affected by family members who have overdosed. SPPD will continue to work with embedded social workers to connect with individuals and their family quickly after an overdose.

SPPD requests a Category 1: Local Application for the Comprehensive Opioid,

Stimulant, and Substance Abuse Site-based Program. A Researcher from the University of

Wisconsin-Madison Population Health Institute has committed to supporting the project to assist
with evaluation development and implementation, data collection, and reporting. SPPD is
currently implementing BJA's 2018 Justice and Mental Health Collaborative Program, which is
also supported by University of Wisconsin-Madison Population Health Institute Researcher.

Priority considerations addressed in this application will also include Qualified Opportunity

Zones within the City of Saint Paul and high-poverty rate of 20.4%.

A. STATEMENT OF THE PROBLEM

Insufficient Data: In 2019, SPPD started using High Intensity Drug Trafficking Areas (HIDTA)'s Overdose Detection Mapping Application Program. This was the first attempt at tracking both non-fatal and fatal overdoses that are reported in the City of Saint Paul. With this

data, a more accurate representation was shown of how many overdoses occur each year. In the first year of utilizing ODMAP, the City of Saint Paul saw over 800 non-fatal and fatal overdoses.

The data collected was used to track overdoses in real-time. The real-time data shows when there is a spike in overdoses. SPPD has created procedures to respond to those spikes, including community notification and education, outreach, and notification to nearby police departments, shelters, hospitals, and other community partners. When conducting outreach, we have found that victims are eager to share information about why they overdosed. Typically, the victims are upset that their chemical dependency almost ended their life and want to get connected with some sort of resources. Most victims who are not currently receiving services, either do not know their treatment options or have barriers to receiving them.

Knowledge and education: An issue of street drug lacing also exists in the City of Saint Paul, and this is leading to many of the overdoses in the City. The narcotics currently on the streets of the City of Saint Paul are not always what individuals believe they are. Many times, the victims of overdose say they believed they were taking one drug, but toxicology reports show something completely different, which led to the overdose. SPPD attempts to keep up with current drug trends, but currently most of SPPD's efforts are dedicated to narcotics investigations, drug trafficking cases, and criminal drug possession and delivery cases. SPPD would greatly benefit from a dedicated team that is in contact with HIDTA and neighboring departments to be aware of drug trends, laced narcotics, and to investigate the source. With this information, the RAP Program would be able to educate individuals and to encourage them to be careful when using their drug of choice. These efforts could then deter future overdoses and result in a reduction in spikes of overdoses.

Accessibility to resources: SPPD recognizes that while there are many different treatment and resource options, it can be hard for individuals to get connected due to insurance status, money, eligibility, and capacity at each facility. The City of Saint Paul has many group homes, government and non-profit facilities, clinics, shelters, and other resources. Through the RAP Program SPPD would connect individuals to available services via a warm hand-off. SPPD and embedded social workers would also make sure that individuals get connected with insurance, Medicare, or veteran services if needed.

Getting individuals connected with resources can also depend on the timing. Overdose victims have a short timeframe after the incident when they are willing and motivated to connect with resources. Through the RAP Program, SPPD would engage with individuals quickly following an overdose incident and would offer to connect individuals with needed services.

SPPD will also offer to take the individual to the appropriate facility to help start the process as well.

Current Process: SPPD is currently implementing the 2018 BJA Justice and Mental Health Collaboration Program (JMHCP) grant which includes a co-response to individuals experiencing mental health crises. Through the JMHCP grant, SPPD partners with Ramsey County Adult Crisis and People Incorporated to provide embedded social workers that co-respond with SPPD Officers to calls for service involving individuals in crisis situations. This co-responder model sparked the idea for chemical dependency outreach. Often, individuals with mental health diagnoses are also battling chemical dependency and co-occurring disorders. Individuals with chemical dependency issues can be mistaken for having mental health disorders.

SPPD is determined to approach these battles with a personalized response, recognizing that individuals may need a variety of resources in order to best help them.

After recognizing the need for this co-responder intervention to overdose calls, an SPPD officer and social worker started going to the homes of individuals who have overdosed to see if they can connect these individuals with needed services and resources. However, this co-response is currently limited to a part-time basis due to the volume of mental health-related calls, and the part-time basis is not enough to address the needs of the citizens. The COSSAP grant would allow for an officer and social worker to be dedicated to solely serving individuals with chemical dependency disorders. It would also allow for SPPD to distribute and provide education about Naloxone for individuals who have overdosed, which would guard against future fatal overdoses while individuals are in the process of connecting to needed resources.

In early 2020, the RAP Program agreed to partner with the Minnesota Department of Health (MDH) to act out a Naloxone Plus model, giving SPPD \$270,000 over three years. The Naloxone Plus model is meant to give individuals the emergency naloxone and other tools, such as sharps containers, to keep individuals safe if they do decide to use drugs. The model also plans to connect individuals with treatment and resources as soon as possible after the overdose incident. SPPD was already doing part of the Naloxone Plus model, but on a part time basis. The MDH funds are being used to partner with People Incorporated to have a team prepared and dedicated to assist individuals who connect with the RAP Program through outreach. This team consists of a Licensed Clinical Social Worker, Licensed Alcohol and Drug Counselor, and a Peer Support Specialist. This team can assist individuals with getting connected to a variety of resources in different capacities.

The MDH grant is an important start to the Recovery Access Program to add much needed personnel and opportunities. However, the MDH grant does not allow the purchasing of naloxone. The COSSAP grant would supplement the money for the naloxone, as well as more personnel, giving the RAP Program the supplies and team members, it needs to really thrive. The majority of MDH grant funds are allocated to People Incorporated to staff behavioral health services in order to have the proper connections. The RAP Program finds it important to have naloxone available to give to chemically dependent individuals and their family and friends in order to prevent fatal overdoses while connection to treatment occurs.

B. PROJECT DESIGN AND IMPLEMENTATION

SPPD plans to expand the RAP Program in order to adequately respond to overdoses. As previously stated, these efforts have been on a part time basis, until granted funds from MDH. The COSSAP grant would allow for an Investigator/Sergeant, data analyst, and would include the addition of program evaluation assistance from the University of Wisconsin-Madison Population Health Institute. The addition of these individuals means supervision and more time dedicated to this project, as well accuracy and consistency in data collection. The proposed program evaluation would provide processes for effectively monitoring program implementation, providing evidence-based approaches to ongoing program improvements, and plan for measuring outcomes that will support sustainability for the RAP Program beyond grant funding.

Collaborative efforts from SPPD, People Incorporated, and other community agencies and organizations will ensure individuals will be connected with the proper services to address their individualized needs. The proposed grant staff will consist of one data analyst, one Licensed Clinical Social Worker, one full-time Officer, and one full-time Sergeant. One Licensed Alcohol

and Drug Counselor and one Peer Support Specialist will be on standby as well through the MDH grant. The proposed model to be implemented will include:

Naloxone Plus Model: Members of the RAP Program will quickly connect with individuals who have recently overdosed and will distribute naloxone as an emergency tool. The RAP Program will also educate the individual and family members on the procedures for properly administering naloxone. The RAP Program will engage with individuals who have overdosed and will offer resources through members of the MDH grant team, such as the Licensed Clinical Social Worker, Licensed Alcohol and Drug Counselor, and Peer Support Specialist. This team will be available at any time, and the officer of the program will be able to connect and transport the individual to the team if requested. This easy and quick accessibility to treatment will reassure the individuals that SPPD and the City of Saint Paul care about their health and wellness, while helping individuals make expedient decisions to utilize available resources faster, lowering the risk of future overdoses.

Embedded Social workers for Individuals and Family: Social workers will prioritize families and children who are affected by overdose and chemical dependency. Social workers will ensure that children have the proper resources as well as proper care. Education for family members on how they can assist their love one daily and in emergencies will be provided. A current fatal overdose scene proved that quick access to resources for family members is extremely important for SPPD and the City of Saint Paul.

Chemical dependency Liaison: An Investigator/Sergeant will be specifically assigned for this program, giving the RAP Program the structure and leadership it needs to work sufficiently and efficiently on its own. Currently, the RAP Program does not have a Sergeant dedicated to

this project, creating barriers for the Officer and other members of the team. That Sergeant will be responsible for the oversight and organization of the RAP Program. The Sergeant will also be responsible for advocating for this program throughout the department and community, as well as advocating for the individuals served through the program. A Sergeant is necessary for this program because they will act as a liaison between SPPD and other community leaders and stakeholders to address any barriers to access of services that arise during implementation.

Drug Surveillance Program: The Drug Surveillance Program will assist the RAP Program in knowing what to look for on the street. While conducting outreach is effective, having real-time knowledge of what drugs are being used, and what drugs could be laced with a fatal substance, can help the RAP Program better assist the community. MDH has offered testing of drugs in cases that SPPD will not pursue charges on. This will help the RAP Program know if individuals are taking the drugs they intended to, or if it was produced to be something different and/or lethal.

MDH has a lab and are willing to test any drugs that SPPD will not need for prosecution and evidence purposes. If SPPD would like to test a drug to find out what it is composed of, SPPD will call MDH and ask for permission to drop it off at the lab. MDH will have an answer in less than 24 hours, which would give SPPD important drug type information. This information can help in outreach and everyday work, but it can also help during overdose spikes. During the overdose spikes, if there is a drug type correlation and it is confirmed by drug testing, SPPD knows exactly what to warn the community about.

Goals: SPPD intends to decrease overdose fatalities. SPPD also intends to distribute at least 200 doses of naloxone to chemically dependent individuals or their family and friends each

year of the grant. The RAP Program hopes to create a guide for other law enforcement agencies in Minnesota for this kind of program as well.

C. CAPABILITIES AND COMPETENCIES

Organization Capacity: The RAP Program works within the Community Outreach and Stabilization Unit (COAST Unit). The COAST Unit is tasked with serving individuals who are unsheltered, chemically dependent, battling mental health disorders and/or battling co-occurring disorders. It is currently comprised of one Data Analyst, three Social Workers, five Officers, and one Program Coordinator/Sergeant. The COAST Unit is led by SPPD, which is the second largest law enforcement agency in Minnesota. SPPD has over 600 sworn officers, and over 150 civilian employees supporting the agency.

People Incorporated, a non-profit organization for behavioral and mental health services in Minnesota, has partnered with SPPD for the BJA JMHCP grant and the MDH grant. If granted the COSSAP funds, People Incorporated will continue to support the RAP Program with a Licensed Social Worker, Licensed Alcohol and Drug Counselor, and a Peer Support Specialist. People Incorporated serves over 12,000 clients each year.

Sub-award Partner:

University of Wisconsin-Madison Population Health Institute: Researchers from the University of Wisconsin Population Health Institute (UWPHI) have committed to supporting the project through providing assistance with evaluation plan development and implementation, assisting with evidence-based decision-making to inform ongoing program improvements, and assisting with outcomes evaluations to inform sustainability beyond grant funding. UWPHI is a

member of the e-Consortium for University Centers and Research for Partnerships with Justice Practitioners.

Project evaluation support will be provided by Janae Goodrich, who has more than ten years of experience collaborating with state, city, and county agencies to lead program evaluations on federally-funded projects at all points on the sequential intercept model that focus on criminal justice and mental health populations, treatment court programs, and court diversion programs. Example projects include serving as a statewide evaluator for the Wisconsin Treatment Alternatives and Diversion (TAD) program from 2008-2014, currently assisting the Saint Paul Police Department with evaluation of a Mental Health Response Team through BJA's "Justice and Mental Health Collaboration Program.", and currently providing evaluation support for the Madison Police Department's Pathways to Recovery Project through BJA's 2019 Comprehensive Opioid Abuse Site-Based Program.

D. PLAN FOR COLLECTING THE DATA REQUIRED FOR THIS SOLICIATION'S PERFORMANCE MEASURES

An SPPD Data Analyst will conduct the gathering and reporting of required grant performance measures in a manner that will ensure accuracy and consistency in the data. The SPPD Officer and Sergeant will collect the necessary data within the current SPPD records management systems and developed Microsoft applications. The Data Analyst will develop and refine a tracking solution to ensure that all data requested by the Comprehensive Opioid Abuse Site-based Program Performance Measures is obtained. The data analyst is familiar with the PMT and BJA requirements from the JMHCP grant SPPD and will continue reporting for the COSSAP funds as well.

Local evaluation support will be provided by the University of Wisconsin-Madison Population Health Institute (UWPHI), a member of the e-Consortium for University Centers and Researchers for Partnerships with Justice Practitioners. UWPHI will work closely with the SPPD Data Analyst to provide assistance with developing and implementing a local data collection and evaluation plan. Grant funds have been set aside for this partnership. UWPHI will provide ongoing training and assistance on data collection plans to the SPPD Data Analyst and other relevant project partners. UWPHI will also assist with identifying key terms and definitions for data collection, reviewing SPPD current records management systems to identify fields for data collection and will provide information about best practices for sharing along several points of service. UWPHI will also provide assistance with defining procedures for information sharing across agencies to address NIBRS, CJIS, and HIPPA regulations and human subjects. On an ongoing basis, UWPHI will aid with reviewing collected data, using data gathered to inform evidence-based decision-making in the continual quality improvement process, and ensure that data is being collected in a way that will support sustainability beyond grant funding. UWPHI will also assist with reviewing required grant data prior to submission to the PMT system. SPPD also agrees to work closely with researchers selected by BJA who may conduct a site-specific or cross-site evaluation in future years.

4. C. Budget Information on Sub-awards

The Saint Paul Police Department (SPPD) request for funding includes resources to enter sub-awards or procurement contracts with one partner who has been named in this proposal. Sufficient detail of the partner's role has been defied in this proposal and budget narratives. As such, SPPD is seeking authorization from OJP for this sub-award and procurement contract through the application review and approval process. A summary of the partner financial share of the award and their role on the project follows:

University of Wisconsin Population Health Institute (UWPHI) @ \$45,000 (\$15,000 in each of three years)

Will provide technical assistance and oversight for performance-based evaluation plan defined during the first year.
