Re: Remove or Repair of the Structure at 750 Chatsworth Street South

Dear Mr. Hortelius, Mr. Bernier & Mr. Soczynski:

This is to confirm that on November 24, 2020 at the Legislative Hearing, Marcia Moermond recommended that the City Council order the above-named property removed within 15 days of the Council Public Hearing with no option to repair. Please note, since you had indicated that you may wish to proceed with demolition yourself, the City would need to see a signed contract with a licensed demolition contractor and title of the property cannot transfer prior to demolition.

I have enclosed samples of accepted loan example documents people have used to transfer title in the past. However, please note that these were for rehabilitation of the property, not for demolition.
