On Wednesday, 06/10/2020 at approximately 0209 hrs, I, OFFICER VA LEE (SQUAD 216) along with CENTRAL PATROL OFFICERS, K9 OFFICERS and RAMSEY COUNTY SHERIFF'S DEPUTIES were dispatched to Giant Wash Coin Laundry, 1675 Rice Street for a Burglary.

CAD information stated "Grp if 5 PPL appear to be breaking into the laundromat."

Upon arrival, I (SQUAD 216) along with Saint Paul K9 OFFICER YUNKER (SQUAD 634) approached the northwest entrance door to the business on foot. We saw that unknown person(s) used an unknown object to break the glass door and entered the business. As we stood outside, we could see that a Kahuna ATM Solutions terminal was damaged and tipped over onto its side from inside the business. We crawled through the broken lass door and entered the business. We searched the business and did not locate anyone inside. I went to the ATM terminal and saw that it was heavily damaged. I did not see any currency inside of the ATM terminal. At this time, stolen currency amount was unknown.

Saint Paul K9 (634) left the scene to assist on a track for possible suspect(s) so I stayed behind to secure the business. I walked through the business and did not see any additional damage inside of the business.

I spoke with Complainant via my department issued cell phone who requested to remain anonymous.

Complainant stated she resided in an apartment at the Larpenteur Villas Apartments, 180 Larpenteur Avenue. Complainant stated her apartment faced Albermarle Street so she was able to see the strip mall from her apartment window. Complainant stated she heard "dragging" noises so she looked outside of her window and saw approximately 5 individuals wearing hoody sweaters but she was not able to see their faces. Complainant stated one of them wore a yellow hoody sweater. Complainant stated the individuals were kicking and yanking on the doors to the businesses. Complainant stated she saw the individuals holding unknown objects in their hands as they ran back and forth from the businesses. Complainant stated she believed the individuals were breaking into the businesses so she called 911. Complainant stated she did not have additional information.

Inside the laundromat, I located a phone number (612-834-5436) for "LIVE Customer Service" on the Employees Only door. I attempted to contact anyone at that number with negative results. I located a phone number for Integrated Protection Systems (763-250-9779) on a sign on the outside of the business. I spoke with Service Tech/DAVID WAYNE STIYER (DOB: 10/04/1963) via department issued cell phone who stated his company managed the 24 hour camera surveillance for the strip mall. STIYER stated he was not able to locate an updated business owner information but will check his records when he returned to work at 0800 hrs this morning. I contacted Ramsey County DATA/Dispatch who stated they were not able to locate any owner information on file so a board up crew will respond to the scene to secure the business.

I checked the Lamplighter Lounge, 160 Larpenteur Avenue and Fantasy Nails, 166 Larpenteur Avenue businesses for any suspicious activity with negative results. All business doors were secured.

OFFICER WEBER (SQUAD 225) arrived and remained on scene for the board up crew to secure the business.

I left a business card with case number inside the Giant Wash Coin Laundry.

All photographs of the damages to the laundromat door and ATM terminal were uploaded to the Media Vault.

NARRATIVE

On 6/10/2020 at 0209 hours, I, Officer House Squad 228, responded to 1675 Rice St to a report of burglary in progress to the Giant Wash Coin Laundromat. Dispatch advised that the complainant could see about five males and females wearing dark clothes breaking into the business. Upon arrival, Ramsey County Deputies were on scene and advised that a glass door had been broken out. Officers also advised that the ATM machine inside the business had been broken into. Ramsey County Deputy Johnson then aired that he saw one of the suspects running Eastbound past the car wash at Montana and Rice St.

I responded to this area and assisted in setting up a perimeter at Hoyt/Rice Street facing Eastbound. It should be noted that the last know location of a possible suspect in the burglary was just South of this intersection. A short time after I stopped my squad car, I saw a male wearing a dark shirt and dark shorts walk out of the perimeter from between houses on the South side of Hoyt Ave and cross to the Northbound side of the street into an apartment building parking lot. I aired this information to other Officers and approached the male from behind in my squad car with my emergency lights activated. The male continued to walk away and I directed him to stop.

The male turned toward me and I could see that he was sweating heavily, as his shirt was wet in the front neck/chest area and his skin appeared damp. This males appearance made me believe he may have been one of the individuals seen running from the area of the initial burglary. I gave him several verbal commands to walk toward me with his hands on his head, however he attempted to argue instead of following directives. I told him he was being detained regarding a burglary, to which he said, "Go look at the cameras." (It should be noted that I did not reference the burglary being a business nor having surveillance at this point.) Due to the

males defiant behavior, I requested an additional squad to assist me. Once other Officers arrived, I placed the male in handcuffs behind his back (double locked and checked for proper fit). He was ultimately identified as ASHFORD, TYRELL TERRENCE (DOB/2001-02-28).

Ramsey County Deputy Johnson advised me he did not believe ASHFORD was the single male he saw run near the car wash, however there were several people wearing dark clothing reported to be involved that ran from the area. ASHFORD made inconsistent statements about what he was doing in the area. ASHFORD initially said he had come out of his house at 98 Hoyt Ave just to see what was going on with the Police Officers. ASHFORD then said he is homeless and is staying in his truck that was parked at the car wash at Montana/Rice St. Officer Wencel Squad 220 checked the parking lot of the car wash, where he located the vehicle ASHFORD was referring to, (2003 Black CHEV TAHOE MN LIC/550HDR 4 DR WAGON/SP UTIL). Officer Wencel advised me that the windows were fogged on the vehicle and the drivers door was left open. At this time, Officer Wencel stated there were no apparent items that appeared to be related to the burglary in the vehicle. ASHFORD had not taken his cell phones from the vehicle and the vehicle door was left open as if he left the vehicle quickly.

I queried ASHFORD's information and located an outstanding Misdemeanor Ramsey County Warrant for Criminal Damage to Property (Reference Warrant #62CR203369), which I was able to confirm through DATA. I contacted other Officers on scene and at this time, there was no further identifying information regarding the burglary suspects as the video footage was not yet available from Giant Wash Coin Laundry. I told ASHFORD he was under arrest for the outstanding warrant and transported him to the Ramsey County Jail. (ASHFORD requested that he be able to get his three cell phones from the vehicle at the car wash, however at the time of his arrest, the vehicle was inside the perimeter that Officers were holding and a K9 track was being completed. I was therefore unable to retrieve any property from the vehicle.)

ASHFORD was booked on the Misdemeanor Ramsey County Warrant. Sgt. Brubaker Squad 202 was briefed on the arrest. See other Officers reports for further details.
