Once on scene, we checked the exterior of the building and did not observe any obvious signs of forced entry. It was at this point that we attempted contact at the front door but could not get anyone to answer our knocking. We attempted several call backs, all with negative results.

A short time later, I was notified by another squad on scene that they had observed several juvenile aged individuals upstairs. This Officer told me that he had motioned for them to come down to speak with us but no one every came down. We began to think that possibly someone (suspect) was potentially still inside preventing the juveniles from coming down to speak with us. We then continued to knock while coordinating more squads to respond to our location in the event that a suspect was still inside holding the occupants against their will.

As we attempted to make contact with the occupants inside, I also had seen the two juveniles upstairs and also motioned for them to come down to the front door but I also got no response.

A short time later, with the perimeter surrounded, I attempted to turn knob of the front door to discover the lock and handle broken and the door opened with little effort. Once the door was open, I could see that the door in fact had been kicked in.

With this observation, myself and Officer Xiong (631) began making announcements at the front door for anyone inside to come out to the sound of our voice. It was at that very moment, a female later identified as, CHANTEL VENESHA JONES, **Mathematical**, 818 Sherburne Ave W, C/P: 651-424-3537) came down the stairs and spoke with us at the front door. WILLIAMS had told us that she had heard us knocking but didn't want to speak with the Police because she was not trying to get us involved.

JONES was visibly shaken and very hesitant to speak with us but eventually told me that her ex boyfriend, RAHIEM CRY **Method** had been kicked out of the house for cheating on her, and upon getting kicked out of the house, kicked down the front door down and assaulted, JONES. JONES was also very hesitant at speaking openly with me but eventually told me that "CRY" had head butt her in the nose/mouth area before fleeing the area after JONES told "CRY" that she was going to call the police. It should be noted that JONES initially told me the suspects name was RAHIEM CRY but it was later determined that JONES lied about the suspects name. I eventually discovered that the suspect was going to be, BLACKSON RAHIEM CRYER **Method**).

Blue print questions were asked. Please see supplement for answers.

After gathering information, we took photos of JONES.

We requested a board up crew to secure JONES'S front door.

We had JONES sign a medical release form at which point, JONES said that she will be making an appointment with her dentist to get her teeth examined. It should be noted that no visibly injury was observed to JONES'S face or teeth.
