Dear Mr. Hulke, Ms. Anderson, Mr. Klemm, Mr. Olson & Mr. Franzen:

This is to confirm that at the Legislative Hearing on December 22, 2020, Marcia Moermond, Legislative Hearing Officer will recommend that the City Council grant 180 days to rehabilitate or remove the above-named property if the following conditions are met by close of business January 4, 2021:

- 1. Pay the pending vacant building fee of \$2,127 for 2020 to 2021 with the Department of Safety & Inspections;
- 2. Submit completed & signed documents including purchase agreement, addendum, promissory note, mortgage, etc; and
- 3. the property must continue to be maintained
