

**NOTICE OF VIOLATION  
RECOMMENDATION FOR IMPOSITION  
OF \$500 MATRIX PENALTY**

RE: Cigarette/Tobacco and Gas Station license held by Mini Pac for the premises located at 1184 Maryland Avenue East in Saint Paul.  
License ID #: 20180004316

Mr. Hammad:

The Department of Safety and Inspections (“Department”) will recommend adverse action against the Cigarette/Tobacco and Gas Station license held by Mini Pac LLC (“Licensee”) for the premises known as Mini Pac located at 1184 Maryland Avenue in Saint Paul. (“Licensed Premises”).

Saint Paul Legislative Code §310.05(m)(2) provides for a presumptive penalty of \$500 for a first-time violation of a provision of the legislative code related to the licensed activity.

Saint Paul Legislative Code §324.07(f) prohibits a licensee from selling, offering for sale, or otherwise distributing any flavored products.

The Department asserts the following facts along with attachments herein constitute proof of a violation of Saint Paul Legislative Code §324.07(f) by a preponderance of the evidence.

**Synopsis of alleged facts:**

On October 8, 2020, Inspector Joseph Voyda conducted an inspection at 1184 Maryland Avenue East because of a complaint for selling flavor tobacco products. He asked the store owner Randy Hammad to go behind the counter to conduct a flavor inspection. During the inspection Inspector Voyda observed and documented violations of Saint Paul Legislative Code §324.07(f). Specifically, he observed ‘Backwoods Cigars’ Russian Cream, Honey Bourbon and Honey Berry. Inspector Voyda asked the clerk if there were any other flavored products. The Clerk was advised to remove all flavored products and place them in a backroom or off the premises.

As the Licensee you have four (4) options:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **December 14, 2020**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council Consent Agenda for approval of the proposed remedy.
2. You can admit to the violation and pay the \$500.00 matrix penalty. If this is your choice, send the payment directly to DSI at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **December 14, 2020**. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered a waiver of the hearing to which you are entitled.
3. If you wish to admit the facts but you contest the \$500.00 matrix penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **December 14, 2020**. The matter will then be scheduled before the City Council to determine whether to impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
4. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **December 14, 2020**. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

Please note: If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing, per Saint Paul Legislative Code § 310.05 (k).

**If you have not contacted me by December 14, 2020, I will assume that you do not contest the imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.**

Details of Conversations (Statements to and by Person Responsible for Property): Upon arrival, I introduced myself as a DSI licensing inspector and introduced a Sergeant from the SPPD that is assigned to DSI, to the owner Randy Hammad. I informed him that I was here today due to a complaint for selling flavor tobacco products out of the office right next to the cashier station that DSI received. I asked I could go behind the counter to conduct flavor inspection, he replied, "yes, yes sure go right ahead", he was very cooperative. Located behind the counter/cash register, hidden behind other non-flavored products, the following flavor products where found 'Backwoods Cigars' Russian Cream, Honey Bourbon and Honey Berry (See Photos – 2 Total). I asked Randy if there were any other flavor products that were present or hidden on the premises, his response was "No". I advised Randy to remove all products that are in violation from behind the cash register and take them off the premises or place them in the back room until they can be removed from the premises.


