Dear Mr. Sathre:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant an additional 180 days on July 8, 2020 for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **January 12**, **2021 at 10:00 a.m. via telephone as in-person hearing is not feasible at this time** at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If your client received the Certificate of Code Compliance by January 12, 2021, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If your client have *not* received the Certificate of Code Compliance by January 12, 2021, you or your client will need to contact Joe Yannarelly (joe.yannarelly@ci.stpaul.mn.us or 651-266-1920) to schedule an inspection to occur *prior to* the week of January 12, 2021. Both Mr. Yannarelly and/or Nathan Bruhn will conduct this inspection to determine percentage of completion.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, January 27, 2021 at 3:30 p.m. remotely.
