Dear Mr. Bier & Mr. Steinmaus:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant 180 days on June 24, 2020 for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **December 22**, **2020 via telephone between 10 and 11:30 a.m.** at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions. Please let me know who will be participating in the hearing and the best number(s) to reach at.

If you received the Certificate of Code Compliance by December 22, 2020, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received the Certificate of Code Compliance by December 22, 2020, you will need to contact Joe Yannarelly (joe.yannarelly@ci.stpaul.mn.us or 651-266-1920) to schedule an inspection to occur *prior to* the week of December 22, 2020. Building Inspector Nathan Bruhn will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, January 6, 2020 at 3:30 p.m. remotely. You may submit written testimony to CouncilHearing@ci.stpaul.mn.us or call 651-266-6805 or let me know before noon if you want to contest via live testimony.
