Approving and authorizing charge off an HRA loan to Printers Row LLC, District 17, Ward

Kristin Guild, Interim Executive Director, stated that this request is for the approval of a loan charge off to Printers Row LLC, connected with taking back the property under the terms of the redevelopment agreement for the sale of the property. The intention is to issue a new RFP for redevelopment of the property.
