1. Resolution approving the re-subordination and extension of the terms and affordability periods of five HRA/City deferred loans associated with Minnesota Vistas and Minnesota Place projects due to refinancing of first mortgages, District 17, Ward 2

Kristin Guild, Interim Executive Director, stated this request is related to financing for a 2010 affordable housing development with 137 units located at 4th and Cedar Street.

Commissioner Prince spoke in favor of this project.

 Authorizing the Housing and Redevelopment Authority to accept gifts and donations that will help the City of Saint Paul to plan, prepare for, or respond to the COVID-19 outbreak.

Ms. Guild stated that agenda items #2 and #3 are actions providing authority to HRA staff to be able to accept gifts, donations, and apply for and receive grants connected to COVID response actions. This action is aligned with a parallel action at the City Council regarding future applying for and acceptance of potential awards connected with COVID-19.

3. Authorizing the Housing Redevelopment Authority to apply for and accept grant funds to plan, prepare for, or respond to the COVID-19 outbreak

4. Resolution accepting a grant of up to \$115,000 from the Saint Paul & Minnesota Foundation; and amending the 2020 Housing and Redevelopment Authority budget, Citywide

Ms. Guild stated this action is to accept private donations of up to \$115,000 to the Saint Paul Bridge Fund.

Commissioner Noecker shared her support for the program.

Chair Tolbert thanked the Saint Paul & Minnesota Foundation for their generous support of the program by serving as fiscal agent.

Resolution approving and authorizing (i) the establishment of the Tax Increment Financing District (West Side Flats Phase III Apartments Project) (a housing district) in the Riverfront Redevelopment Project area and a Tax Increment Financing Plan therefor, (ii) an amendment to the Tax Increment Financing Plan for the Riverfront Renaissance Redevelopment Tax Increment Financing District, (iii) the conveyance of land, (iv) a Loan of up to \$990,000 in HOME Funds and the execution of related documents, (v) the execution of a tax increment development agreement, LCDA and TBRA Subgrant agreements, and related documents, and (vi) an HRA budget amendment, all for the West Side Flats Phase IIIB Apartments Project, District 3, Ward 2

Ms. Guild stated items #5, #6 and #7 are all related to the West Side Flats redevelopment project with the result being a mixed income community near the Mississippi River.

Commissioner Prince and Noecker thanked staff for their hard work and shared their support on this project.
