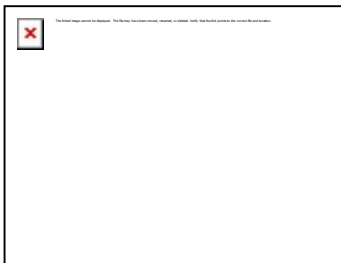
**Think Before You Click: This email originated outside our organization.**
