I am reaching out to you following communications with Ruby and Lee Vang. Lee is going to be submitting revised and more thorough plans for the construction of the rear porch based on my assessment of the footing placement that will be necessary for code compliance. This will change the framing detail as well. Ruby has requested that I contact you to keep you in the loop on the delays that we are facing. Since the soils are frozen, we are looking at spring time when the soils have thawed to begin the construction of the rear porch. In the meantime, Ruby is going to proceed with siding and windows on the other three sides of the home. She is aware of the archtop window replacement on the North side

of the home should resemble the previous archtop window that was removed. I know this is not ideally what you were looking for with the timeline but Minnesota winter is playing it's card. Ruby is aware that we need to begin the construction on the porch as soon as the soils have thawed in the spring.
