Utility to pay for WUTT classes

The first module in the program, Water Distribution Operator, begins March 1, 2021. This module is an overview of a water distribution system from treatment to the faucet to provide safe, reliable water to our customers.

Complete all nine modules (eight weeks each) to be eligible for the MN Water and Wastewater Operator Certification and the ability to test for your class D water operator license.

The program offers convenient online and evening courses, which need to be attended on personal time.

Overtime work is an expectation of the position and includes reporting to work at any time during emergency conditions such as when water main breaks occur. This position usually works from April through November and is then laid off during the winter months.

Applicants must apply online at stpaul.gov/jobs by Feb. 1 at 4:30 p.m. Must possess and maintain a valid Minnesota class D driver's license or equivalent outof-state driver's license.

A computer-based assessment will be required and consists of multiple-choice, true or false, and simulated questions developed to assess your knowledge of basic math, reading comprehension, communication, computer skills, and teamwork.
