## NOTICE OF PUBLIC HEARING

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## Description of Variance:

Location: 2383 University Ave. W.

Noise Source: Kraus Anderson has requested a sound level variance, for 85-125 dBA measured at no specified distance from the sound source for operating sheet pile driving construction equipment. The variance is requested for the hours of 7:00 a.m. to 5:00 p.m., February 11, 2021 or the date following City Council approval through March 21, 2021. The Department of Safety and Inspections will be recommending the following conditions: 1) the Variance shall be for the hours of 7:00 a.m. to 5:00 p.m., at 2383 University Ave. W. 2) The Variance will include elevated sound level limits from 7:00 a.m. until 5:00 p.m. from Thursday, February 11, 2021 or the date following City Council approval through Sunday, March 21, 2021. 3). If the sound level variance is approved, Kraus Anderson Construction Company and Ramsey Company will notify in writing, all property owners/residents within 400 feet of the proposed work location. Notification shall be a minimum of forty-eight (48) hours prior to the start of the work. The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) Contractors working on the project to use best practicable methods for controlling noise, such as, but not limited to noise blankets, shields or portable sound barriers. Construction activities should be scheduled to minimize noise as much as possible.
