Dear Ms. Moermond and Ms. Vang:

This matter is set for a Legislative Hearing on Tuesday, February 2, 2021, via phone conference between 11:00 a.m. and 1:00 p.m.

Mr. Stadler is currently recovering from injuries after falling on the ice and is requesting a continuance. He is unable to walk without immense pain and has had his leg x-rayed, had an ultrasound, and may need an MRI in addition to having the blood drained that has pooled in his leg. He will be seeing the doctor again this afternoon.

Mr. Stadler advised me by email correspondence as follows:

“I will take the greenhouse down, however, because the steel poles supporting it go down 2 - 3 feet, and it has a cement base, I won't be able to do anything until the ground thaws to the extent I can pull it all out, which in Minnesota, as you know, can be late Spring or even early summer. And because the Covid virus is still a problem, and now these new versions of it are showing up, it is difficult to

put a date on it -- I don't see it getting done before late June or July. I don't know that they will like that....but even though they say it is not a permanent structure, I put it up as a permanent structure with strong supporting elements ... steel and cement.

Also, I do not intend to put up a garage or any other building. This has gotten to be way too much for me. The fact that they have harassed a lifetime St Paul Resident... a 77-year-old survivor of cancer, chemo, triple bypass surgery. stroke and cardiac arrest (3 of these events while this situation has been playing out) is truly appalling ...”

We would sincerely appreciate a continuance to give Mr. Stadler time to recover. We look forward to hearing from you.
