		John McCarthy said he is going to share a presentation. At last week's meeting, the Council voted to spend some. This is moving the remaining amount. (He shared his desktop presentation.) Saint Paul received about \$23.5 Million. There are strict eligibility rules. It has to be spent by November 15. It cannot be used as a revenue replacement. We put together a strong review process. This card has been led by Laura. They have brought in an expert consultant. The resolution will allocate the remaining \$20 Million across 4 categories: 1) Director COVID response, 2) Economic

Councilmember Prince said she has 2 questions. What is the timing challenge to have it all spent by the middle of November? McCarthy responded that the State has imposed the November 15 deadline. We know we have more than the amount in needs.

recovery, 3) Unsheltered Homeless, 4) Enhanced Service Delivery. That November 15

timeline is very tight.

Prince said her second question—3 members are on the Visit St. Paul board—did others submit COVID costs? McCarthy said they are working with Visit St. Paul and RiverCentre.

Councilmember Noecker said that nonprofits are suffering, too. McCarthy said they are working with partners in PED. There is nothing in the eligibility rules that would prohibit us in providing financial support for those organizations, too. They have to be COVID related financial impact.

district's boundaries. Despite these grounds, she moved that the Council determine that each land owner opposing and objecting remain in the district and subject to the district service charge as long as they are in the district's boundaries for the following findings: 1) Due notice of the public hearing was given in accordance with State law. 2) Public hearings were held on September 16, 2020, and all landowners were given an opportunity to be heard. 3) Comments were taken via written letter, e-mail, and voice mail, 4) Special services to be provided were specifically defined to express concerns of Downtown landowners, 5) This service is not otherwise provided by other services to the same degree, 6) All properties will receive the special services and benefits, 7) Each will benefit from the special services, 8) These properties are used for commercial purposes and not exempt to the levy of a service charge, 9) Property located outside the boundaries will not be part of the district or be subject to the charge. This is a motion of intent. They will remain subject to the district service charge and it will be memorialized by written resolution.

Marcia Moermond, Legislative Hearing Officer, gave a staff report. 920 Fremont has been in the vacant building program for more than a year. (She shared her desktop.) The main problem is the result of the roof. Water has been infiltrating for years. It has created an unsafe condition. There is not a plan to rehabilitate the property. One of the co-owners is on the line. She continues to have a concern about the property and the safety. Access should be limited and things removed efficiently. Her recommendation is the Council to order the building removed. That would mean the owner has 15 days to demolish the building. If not, the City will take over the removal. Typically that would mean the building would be demolished. That would be 15 days that the owner would have custody.

Susan Drake, appellant, said that she has had all kinds of problems. They have been in a hotel room for the last year. They have used the house for storage. They have not been able to get through to anybody. They have not been treated fairly.

Council President Brendmoen said we are looking at the raze and removal of the property within 15 days. If we move forward, you would have 2 weeks to get items out of the property. Drake responded there is no way they can get items out in 2 weeks.

Councilmember Prince moved to close the public hearing. 6 in favor, none opposed Public hearing is closed

Prince said she had expected that she would need additional time. Prince talked to Ms. Moermond about the possibility to extend to 30 days. If Ms. Drake is still on the line, would 30 days be helpful? Drake responded that would be fine.

Brendmoen said they heard the item last year. They have had time to get the items out of the property. As long as it is open ended, it is hard to move on.

Prince said she will move to amend the Legislative Hearing Officer's recommendation to provide 30 days to Ms. Drake to give her time to get her personal possession out of the building.
