Council President Brendmoen said this item has been before us several times.

Luis Pereira, Planning and Economic Development, said today is the final adoption for comprehensive plan 2040 Saint Paul for All. It has been a bit of a journey since 2015. Staff has been working on this with the community. State law requires cities in the metro area to update plans every 10 years. This has to be consistent with the Metropolitan Council's regional plan. There are multiple chapters in the plan. They began the process in 2015. They had over 70 events with over 2300 residents and 1200 public hearing comments were submitted. This was brought to the City Council for consideration and to the Met Council for review in 2019. They responded to requests for technical edits by Met Council. They brought the draft plan through 2 committees and approving us to put it into effect on November 4. They are excited about that. Therefore, it is in front of Council today. (He recognized the team by mentioning the people who worked on this plan and numerous interns that contributed.)

Councilmember Yang said she is committed to that work.

Staff report from the administration regarding Community First Public Safety.

Daniel Yang spoke, senior policy adviser for Mayor Carter.

Chief Tobolt showed some slides.

Council President Brendmoen said COVID has changed the landscape in many ways and how these investments have been able to move forward or not. Giving some tangible information of what the programs have been focused on this year has been helpful. It is hard to have these conversations virtually.

Mark Kimball with the Healing Streets Program said Healing Streets is for prevention and healing. They wanted to go into the schools with the connection that Danny had. We are communicating the best we can with people.

Brendmoen said it was an honor to work with him. His presence added a lot of value to a day in a park.

Kimball said they have connected with some sergeants. Their cell phones are on 24 hours a day.

Brendmoen said this is a program being created from the ground up.

Councilmember Yang said she loves the component around healing.

Councilmember Thao spoke.

Joe Franklin said that community ambassadors have been around for 7 years. With the additional funds, we were able to expand our teams. We went from 35 to 50 ambassadors. We had a lot of setbacks and challenges due to COVID. The day of the riots after the George Floyd killing caused some problems, too. They will have a team specializing in the skyway.

Councilmember Thao spoke. He has seen a difference in the North End. The team was approachable. We invest in libraries, after school programs. What else are we not doing in helping them make good decisions? Franklin responded it is a tough question. Lots of disputes are around social media.

Councilmember Jalali spoke. Reflecting on students she taught in high school and middle school. We have to address that opportunity gap. We invested in expanding this program.

Councilmember Yang said we will be partnering with them on the citizens league.

Kate Simino, Executive Director of the Citizen's League, enjoyed opportunity to take a deeper dive into the nuances of the work.

Councilmember Prince spoke.

Yang said we are talking about these things today because of policing and other things. That is why we are talking about doing public safety another way. We can't keep doing things the traditional way and uphold the status quo. This is what got her involved in racial justice work in the first place.

Advancing the City's Continued Efforts to Implement a Community-First Approach to Public Safety.

Council President Brendmoen said we have talked about this. We have our update on Community first.

Councilmember Jalali said we heard a report on work that has happened and work is in motion. The uprisings that many people have joined. She joined the Council in 2018 and went straight into the budget cycle. They stepped into a conversation about police discussion. What's to acknowledge. Partnership with the Mayor. It is about stepping forward together into the community. There should be an office of violence prevention.

Council President Brendmoen said she appreciates the thoughtfulness. It is reflecting back what we heard from people. It is important to make a plan. In the resolution, we acknowledge the work of our own Police Department which challenges itself and is willing to look at better ways of policing. It will be received better across the board if it challenges the work we are doing. Looking at dispatch and trying to determine lightening the load from the police department, I want to second that: the Office of Violence Prevention.

Councilmember Noecker wanted to acknowledge Jalali's work. It is hard to balance urgency and thoughtfulness. She strongly supports it and would like to offer an amendment: a further resolved we will hear community first public safety strategies.

Brendmoen said that is a friendly amendment.

Jalali said she welcomes that amendment. Something simple like "be it further resolved that further updates be" or whatever is simple. The spirit of that is right.

Brendmoen said it has been moved. "Ongoing quarterly report to the Council."

Councilmember Tolbert said thank you for putting this work together. Anything we can do to better address actions. The Citizens League group has a deadline. Next year's budget may be harder. I want to defer to my colleagues who put together this resolution if they would be open to that. It would take a layover for proper language. Maybe it would be a separate resolution.

Noecker said she supports the additional study. Don't know if it's possible to put that work into the Citizen's League contract. I know they have a limited amount of time. I would be supportive of a separate resolution.

Councilmember Yang said this is a good conversation. This is something we need to talk about more. There is support for this. I just want to bring that into the space here.

Councilmember Prince said she would also suggest that we handle this at least at a

different time than right now. Part of what you are talking about is a financial audit.

Brendmoen asked given the quick turnaround, is he open to a separate resolution?

Tolbert says he is open to that. He was under the assumption they would take up this information. It is important that we continue to have the funding conversations every year. It would be helpful to do an audit of the external police and the new programs. It would articulate what the value is to public safety. I will work on it separately. We have time before that comes before the Council.

Brendmoen said some of the things we are talking about are the things that the Peoples Cabinet and others would be managing.

Noecker said the commission is a 40-member body. They're going to have 10 meetings. Tolbert's resolution can be framed in such a way that the commission to identify the areas they will not be able to get to.

Councilmember Prince said this comment is on the resolution. She appreciates Jalali and Brendmoen bringing this to her last Tuesday. She spent the weekend on e-mail with the Mayor. She reached out to the district councils. She reached out to people working in the area working with kids, violence, trying to decide if this is the right approach. It is clear the study is moving ahead as planned whether or not she votes for it. One thing she wants to say to them is what the resolution is not: it cannot be a huge spike in gun violence in Saint Paul. Reverence Spence said a 6-month study will not save the young people's whose lives are on the streets at night. Recently after witnessing a high speed chase, she called our East Team Commander and he said he worries about sending his team out. The \$1.6 Million has been so hampered in its effectiveness due to COVID and civil unrest. To the things presented tonight, none of these initiatives have touched her ward. A large portion was done very closely and in partnership with the SPPD (Saint Paul Police Department). It is one of the more innovative departments nationally and internationally. She feels with some of this money we could have hired the students. The 13 young adults—all people of color-and these officers would have come online and trained on community first public safety. Instead, we need to save \$3.7 Million through attrition. Leaving of 40 officers. All that said, she will be voting for this. It will be better ways for 911 calls. I believe the number of 48,000 of lower priority calls are off and should be checked. I am voting on this today to make sure East Siders are on this commission. In any event, it is critical the City deal with the sharp rise in crime and destroying the lives of its youth and families.

Toni Newborn shared her screen.

Council President Brendmoen said hit the highlights you would like to cover. Breeze through the stuff that is less controversial. Use your judgment.

Newborn breezed through it. They make up 1.6% of the budget. They put a hold on the deputy director position. Centralizing liaisons into Human Resources. It is not going to happen overnight. Creating a city-wide training framework.

Councilmember Prince said there was an earlier slide for the deputy director pay. Newborn responded she is not sure she will hire at that top level.

Prince said she mentioned that she will continue to have the Chief Equity Officer role. Newborn responded she will continue to serve as both. To integrate the work into Human Resources and citywide. The salary will offset the deputy director.

Prince asked the salary of the chief equity officer. Newborn responded that is around \$151,000.

Prince said that somehow you will take a portion of each salary and the remainder will go to hiring additional staff and a deputy director. Newborn responded the remainder will be making the investments into training and development.

Prince said we are losing so many positions. We are voting on the creation of that position after you present your budget. Newborn responded she understands her concern. She can't emphasize enough the role. Eons ago this position was in Human Resources. The learning and development piece have not been in this position. This is our opportunity. Like anything, it takes adequate financial investment.

Councilmember Noecker said this is all news to her. The last she heard was that the Mayor was going to hire another chief equity officer position. We have such a tight budget. It's hard to make these decisions when the story keeps changing.

Newborn says she has received support to expand both roles. Human Resources is the nucleus of our organization. It is one of the best departments to start with.

Prince said she is confused about the second to last slide. What is going on with all of these salaries? Newborn responded there are salary savings here.

Prince said explain the next box. Newborn responded. It is a \$20,000 shortfall.

Brendmoen said we are out of questions at the moment. We can go through Holly and get things clarified.

Councilmember Yang asked if there was more from DSI (Department of Safety and Inspections). It was laid over.

Brendmoen asked if Ms. Skarda is on the call.

Yang said she is not sure how today will go then. She did a lot of work in criminal justice reform. It was good for us to look at our policies. Restorative justice measures. When she looked at what was in front of us. It was a recommendation to deny the license. Because they had a felony record, it violated the morals. The felony happened outside the City. It is different than what the person is applying for. Why didn't this person come to testify? When I started to ask these questions, they questioned if there were language barriers. There are so many laws need to be dug into. I'm going to have our staff look into this. The City should give second chances. Does this even make sense to write out codes this way? She will leave it there. She will not be supporting the recommendation from DSI.

Rachel Tierney said she was not aware of Ms. Yang's concern. She spoke with Skarda about this case. The conviction involved some misuse of credit card or financial information. There is a State statute, the conviction has to be related to the licensed activity. This practitioner would have access to customer's credit cards and other financial information. I represented DSI in charge of licensing. When people have access to financial information, it has been the position of the department that the conviction is part of the activity. The licensee has the opportunity to explain the us. My understanding this license applicant has not responded to that notice. I understand your passions Ms. Yang, but I want to make sure the legal basis is in front of you.

Brendmoen said she is not sure where to start. Yang, do you have follow-up?

Yang said this is something she was already informed about. She had Dia from her office talk to DSI. She wanted our staff to reach out to this person. None of the councilmembers had that information.

Councilmember Prince said she had this information on October 28th. The concerning piece is that Skarda indicated the licensee could have come forth with a claim of rehabilitation or responded to the letter somehow. When we are sending people a denial, is that information included? Do they know they are encouraged to come forward? I feel like we so frequently deal with people. Are letters are not always necessarily in plain English.

Councilmember Thao said he understands the legal aspect. What we are looking at here is this person has a felony, it is difficult for you to get a good paying job. One of the best ways is to start your own business. We are not giving them our chance. I am not approving this.

Councilmember Jalali said she really appreciates your explaining the framework. I am still trying to understand the nexus here. Do we have other information on the picture of their life? While I expect the DSI processes, I feel like the policy itself needs reform. I'm leaning against supporting the motion. I think it's important to use the information we have. It's always important to bring our values and also the legal framework at hand.

Brendmoen said Thao is sharing his screen.

Tolbert said it finds that the colleagues are doing something different. What are our options right now? This law should be re-looked at; however, by making this person the potential poster child of this law without his consent is disappointing. That's not

fair to him as a person. I'm open to doing something different. Maybe Ms. Tierney came give us the options.

Brendmoen said the one question that comes to mind if we have State guidelines, if we approve it and something happens, are we liable. Tierney responded and said you can always withdraw it and ask DSI to reach out to license applicant. DSI has not heard from him. That outreach can be done. Otherwise, approve the resolution, deny the license, and he can reapply.

Bistodeau says Rachel's suggestion of withdrawing the item and then having a conversation seems warranted. Deputy Director Niziolek is happy to have that conversation.

Brendmoen said we have a full agenda in front of us and a HRA meeting. I don't want to hear people's perspective about information we don't know about. It is under sponsorship of Ward 3. Are you willing to withdraw this item?

Tolbert made a motion to withdraw. If he withdraws, is quasi-judicial gone? Rachel responded sort of. It is likely to come before the Council again so you need to be careful about contacts.

PUBLIC HEARINGS

36 AHPC 20-2

Public hearing to consider the appeal of William Garman ("Gar") Hargens and Mary ("Missy") Staples Thompson to the Heritage Preservation Commission decision of 540 Portland Avenue in the Historic Hill Heritage Preservation District. (Public hearing closed on November 18)

Councilmember Thao requested a staff report

Allison Eggers, planner, said the proposal the HPC (Historic Preservation Commission) approved would be built behind 542 Portland. They propose a 3-unit townhouse at the rear yard of the property. The rear yard is it's own separate parcel that is landlocked. They are proposing to built on this. On the other side of the lot faces Summit. although it does not have Summit access. It is visible from Summit. It is currently used as off-street parking. It has a wood fence on one side and a chain link fence surround. She showed a rendering of the proposal. The architect omitted the existing house to get a better idea of the design. The 3 garage doors would face Portland Avenue. The trees would remain. Staff met with the applicant about the potential project in 2019. February 10, 2020, applicant came forward to HPC for a pre-application review. HPC recommended the project have a covered porch that would face summit to better relate to the rhythm of Summit Avenue. The HPC application was submitted and scheduled for Sept. 21 HPC meeting. Neighbors stated they wanted to know more about the project. Applicant was notified that the neighbors requested a meeting and postpone the HPC meeting and they could talk to the architect about the proposal. The applicant met with the neighbors and made some adjustments to the proposal: design of garage doors, coverings over entryways, location of the dormers facing summit. The revisions were sent to the HPC. Revised application was reviewed at the October 5 PH of HPC. It was approved 5 to 0. Fourteen letters are in support. One person spoke in opposition and there was one letter of opposition.

Councilmember Thao asked when the property owner met with the neighbors and made those changes, was the appellant part of that neighborhood meeting. Eggers responded yes. Thao asked given that timeline, did the appellant have enough time to state their concern and also come before the HPC? Eggers responded yes, the appellant was part of the neighborhood discussions. Neighbors were notified of the new date of the HPC meeting. That meeting took place at the same time at the BZA (Board of zoning Appeals) meeting. They took testimony in writing as well as in person. The appellant did copy HP staff on an e-mail to the BZA stating some of their concerns about the project and their opposition. They did not submit anything to the HPC that was directed to the HPC.

Thao said the HPC guidelines are strict. Was anything borderline in the proposal here that the HPC had to go out of its way to make this work. Eggers said the project was

unique. The long timeline was trying to make sure it followed the guidelines. The applicant was commended by the HPC on their willingness to adjust their proposal to meet the guidelines. They found little push back form the applicant to deliver a proposal that would be successful. The addition of the porches would break up the largeness of the project. Also consider the view from Portland. It would still read as a secondary structure on Portland. That's how they felt it would still comply in terms of its size. HPC commended them on providing density and still adhering to the HPC guidelines.

Councilmember Prince asked about the reasons for error. Eggers responded the reasons for error could be how the guidelines are interpreted if it is inconsistent with other proposals, if the materials don't relate. All of the materials for the project are materials that have been approved for other projects. The massing wall is large and still reads as a secondary structure on the Portland Avenue project. This project is unique because of the landlocked site. There was a large consideration given to the uniqueness of the site. As far as the HPC erred, it would be based on the guidelines.

Prince asked the HPC vote. Eggers responded 5 to 0.

This lot is legally nonconforming as the lot width is only 46.08 feet wide. As a triplex, it would need 60 feet wide. They would need a variance of the lot width requirement. As for the density, several other properties also have higher levels of density. This is in the RT2 zoning district which permits 2 principal dwellings, which is

acceptable for the proposed triplex. This is located in the preservation district, so it means it has to meet the design guidelines from HPC and the porch that the HPC requested that this property provide at the rear, making it a functional front. That porch pushed over both buildings over the lot coverage requirement. It is the porch that pushes it over and makes them have to comply with the lot coverage variance. That same porch also encroaches into the required rear yard setback. HPC wants them to make the rear look like the front. So, when you travel onto Summit Avenue, it would not stick out and it would blend in better with the surrounding properties. Half of the variances that he needs is based off the need to meet the HPC design requirements. The trees are not located on 542 Portland. It is on 533 Summit Avenue. Those trees will be remaining. There are 3 townhouse units within this building and each unit has its own garage. Within each garage, there is its own car lift. They are required to require 10 parking spaces. This does not include this creative solution to the parking solution allowing 2 cars to park in one parking space. They can only count 7 spaces. They are side by side units. The first-floor plan is the garage that go upstairs and leads into the dining room, bathroom, and kitchen. The applicant submitted 17 letters of support; staff received 8 letters of opposition. DSI recommends approval of the condition subject to final approval by HPC and garage lifts are installed. HPC recommends approval. District Council 8 also recommends approval.

Councilmember Thao asked how the neighborhood was notified for the BZA hearing. Graybar responded DSI sent out the notification. They met the 10-day notification to the surrounding properties within 300 feet of the property lines. They also send out an ENS (early notification system).
