I understand that, but assessment goes with property so we need to sort this out. This property was in the Vacant Building Program since September 20, 2019 due to a condemnation for lack of water, which means every September for as long as the building stays vacant, there is this annual fee. There was a Renewal Vacant Building Registration letter sent to Lakeview Loan on August 21, 2020 and a Warning Letter sent on September 21, 2020 telling them the fee was due again which they didn't appealed. Therefore, the fee got processed as an assessment on November 2, 2020. And per inspector's note, the property made aware of the property being occupied since November 23, 2020, which means this property was still vacant 3 out of 12 billable months. Like I stated before, if the Legislative Hearing Officer review this on 2/12 and if it should be deleted, I will let you know and the hearing on 2/16 is not necessary.
